PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 12th day of April, 1923, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now

humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called ‘ the said Benefice ’) of East Kennett, in the County of Wilts and in the Diocese of Salisbury :

“ Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of East Kennett is vested for an estate in fee simple free from incumbrances in certain Trustees upon trust in the first place for William Fisher, of Lloyds Bank Chambers, Hexham, in the County of Northumberland, Esquire, during his life and the said William Fisher is therefore the Patron or person entitled to present or nominate to the said Benefice in case the same were now vacant :

“ And whereas the said William Fisher is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of East Kennett should be transferred to and be vested in the Bishop of Salisbury for the time being :

“ And whereas the Right Reverend St. Clair George Alfred, now Bishop of Salisbury, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the
