## NATIONAL HEALTH INSURANCE ACTS, 1911 to 1922.

Notice is hereby given, under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, after the expiration of at least 40 days from this date, in pursuance of the powers conferred upon them by Section 35 (2) of the National Insurance Act, 1911, and by the National Insurance (Joint Committee) Regulations, 1912, to make regulations prescribing the manner of calculating the maximum sum which may be carried to the administration account of an approved society or branch out of contributions payable under the Act.
