And whereas the Long Melford Gas and Coal Company Limited are Undertakers of the Order and have applied to the Board of Trade for the issue of an Order substituting the price of eight shillings and ten pence per one thousand cubic feet for the said maximum price:

Now, therefore, the Board of Trade, in exercise of the powers conferred upon them by the said section, hereby order as follows:—

1. The price of eight shillings and ten pence per one thousand cubic feet shall be substituted for the price of six shillings and six pence per one thousand cubic feet mentioned in section 18 of the Long Melford Gas Order, 1887.

2. This Order may be cited as the Long Melford Gas (Maximum Price) Order, 1923.
