WHEREAS by Section 737 of the Merchant Shipping Act, 1894, it is provided that where, under that Act, anything is authorized to be done by, to, or before, a British Consular Officer, and in any place outside His Majesty's Dominions in which His Majesty has jurisdiction there is no such Officer, such thing may be done in that place by, to, or before, such Officer as His Majesty in Council may direct:

And whereas the Merchant Shipping Act, 1894, has been from time to time amended by various Acts of Parliament, which Acts are construed as one with the Merchant Shipping Act, 1894, and may be cited together with the said Merchant Shipping Act, 1894, as the Merchant Shipping Acts, 1894 to 1923:

And whereas the British Sphere of the Cameroons, New Guinea, Western Samoa and South West Africa are places outside His Majesty's Dominions in which His Majesty has jurisdiction, but in which there is no Consular Officer:

And whereas it has been made to appear to His Majesty that it is expedient that the officers hereinafter named should exercise and perform in the places aforesaid the powers and duties of a British Consular Officer under the Merchant Shipping Acts, 1894 to 1923:

Now, therefore, His Majesty, by virtue of the power vested in Him by Section 737 of the Merchant Shipping Act, 1894, by and with the advice of His Privy Council, is pleased to direct as follows:—

(1) Anything which is, under the Merchant Shipping Acts, 1894 to 1923, authorized to be done by, to, or before, a British Consular Officer may be done in the British Sphere of the Cameroons by, to, or before, the Officer for the time being acting as Senior Officer of Customs; in New Guinea by, to, or before the Officer for the time being acting as Chief Collector of Customs; in Western Samoa by, to, or before, the Officer for the time being acting as Harbour Master, Apia; and in South West Africa by, to, or before the Officer for the time being acting as Commissioner of Customs and Excise of the Union of South Africa.

(2) This Order may be cited as the Merchant Shipping (Administration in Mandated Territories) No. 1 Order, 1923.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 11th day of May, 1923 (C.W. 11173/23), in the words following, viz.:—

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

“And whereas in the Regulations for the retirement of Officers of Your Majesty's Naval or Marine Force, which have been established by Order in Council from time to time, provision is made for the grant of retired pay at certain rates to Sub-Lieutenants and Paymaster Sub-Lieutenants of Your Majesty's Navy and Lieutenants with less than four years' commissioned service and Second Lieutenants of the Royal Marines if invalidated from Your Majesty's Service under certain conditions:
