And whereas the said Scheme hath been transmitted by the said Bishop to the said Archbishop for his consideration:

And whereas the said Archbishop, being satisfied with the said Scheme, hath certified the same and the Consents aforesaid to His Majesty in Council by his Report dated the 20th day of February, 1923, which said Report is in the words and figures following:—

" We, the undersigned Randall Thomas, Archbishop of the Province of Canterbury, do hereby report to Your Majesty in Council.

" That the Right Reverend William Shuckburgh, Lord Bishop of Lincoln, has represented unto us amongst other things.

" That there is in the County and his Diocese of Lincoln the United Benefice of Immingham with Habrough.

" The Parish of Immingham contains according to the census of 1911 two thousand six hundred and eight persons and the Parish of Habrough contains according to the census of 1911 a population of four hundred and seventy-one persons.

" That there is also in the said County and Diocese the Rectory of Brocklesby which is united to the Parish of Limber Magna the Parish whereof contains according to the census of 1911 a population of two hundred and seventy persons.

" That an outlying portion of the said Parish of Habrough containing an estimated population of three hundred persons is four miles distant from the Parish Church of Habrough but only two miles distant from the Parish Church of Immingham.

" That it appears to the said Lord Bishop, that the said outlying portion of the Parish of Habrough, the boundaries of which are more particularly described in the first portion of the Schedule to the hereinafter mentioned Scheme and verged pink on the plan annexed to such Scheme, may under the provisions of the Act 1 & 2 Victoria, Ch. 106, be advantageously separated from the said Parish of Habrough and annexed to the said Parish of Immingham for Ecclesiastical purposes.

" That an outlying portion of the said Parish of Brocklesby known as Newsham Booth, without population, is nine miles distant from the Parish Church of Brocklesby but adjoins the aforesaid outlying portion of the Parish of Habrough so proposed to be united to the Parish of Immingham.

" That another outlying portion of the said Parish of Brocklesby known as Newsham Abbey containing an estimated population of six persons is nine miles from the said Parish Church of Brocklesby but adjoins the aforesaid outlying portion of the Parish of Habrough so proposed to be united to the Parish of Immingham.

" That it appears to the said Lord Bishop that the said two outlying portions of the Parish of Brocklesby the boundaries of which are more particularly described in the second portion of the Schedule to the hereinafter mentioned Scheme and respectively verged

green and dark green on the plan annexed to such Scheme may under the provisions of the Act 1 & 2 Vict. Chapter 106, be advantageously separated from the said Parish of Brocklesby and annexed to the aforesaid outlying portion of the said Parish of Habrough so proposed to be united to the Parish of Immingham.

" That pursuant to the directions contained in the said Pluralities Act, the said Lord Bishop has drawn up a Scheme in writing describing the mode in which it appears to him that the proposed alterations may best be effected and how the changes consequent upon such alterations in respect of Ecclesiastical jurisdiction Glebe Lands Tithe Rent Charges and other ecclesiastical dues, rates and payments, and in respect to Patronage and rights to pews may be made with justice to all parties interested which Scheme together with the consents in writing of the Right Honourable Charles Alfred Anderson Worsley Pelham, Earl of Yarborough, the Patron or person entitled to present to the United Benefice of Habrough with Immingham and also to the Rectory of Brocklesby with Limber Magna in case the same or either of them were now vacant, the Reverend Ralph Porter Wade, Incumbent of the United Benefice of Habrough with Immingham, and the Reverend Edward Percy Greenhill, Incumbent of the United Benefice of Brocklesby with Limber Magna, has been transmitted to us for our consideration.

" The Representation and Scheme of the said Lord Bishop and the Consents above referred to are hereunto annexed.

" And we, the said Archbishop, being on full consideration and enquiry satisfied with the said Scheme do hereby pursuant to the said Pluralities Act, certify the same and such Consents as aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do make and issue an Order for carrying the said Scheme into effect.

#### TENDERS FOR TREASURY BILLS AND TREASURY BONDS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice, that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 17th August, 1923, at 1 o'clock, for:—

(a) Treasury Bills to be issued under the Treasury Bills Act, 1877, The National Debt Act, 1889, and the War Loan Acts, 1914-1919; and

(b) £4 per cent. Treasury Bonds, repayable at par on the 15th April, 1933.
