APPOINTMENT OF STANDING FOR HACKNEY CARRIAGES WITHIN THE METROPOLITAN POLICE DISTRICT, AND REGULATIONS TO BE OBSERVED.

By virtue of the Act 13 and 14 Victoria, chapter 7, intituled "An Act for consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of the Commissioners of Police of the Metropolis and making other provisions in regard to the Consolidated Offices."

I, WILLIAM THOMAS FRANCIS HORWOOD, the Commissioner of Police of the Metropolis, do hereby appoint a Standing for Three Hackney Carriages at Cranley

Gardens, South Kensington, and do make the following Regulations with regard to the Boundaries for the same, viz. :—

On East side of roadway, commencing 4 yards from the junction with Old Brompton Road, extending Southward, by kerb of garden enclosure, as far as necessary for three carriages.

Front of vehicles toward the North.

Provided that no Hackney Carriage shall be suffered to stand across any Street or Thoroughfare, or opposite the end of any Street or Carriageway, or upon any place where Foot Passengers usually cross the Carriageway.
