borough in the administrative county of Leicester, and thereupon those parishes shall be included in and shall form part of the Controlled Area.

Movement from One Infected Area to Another Infected Area for Immediate Slaughter.

4. Notwithstanding anything contained in the Principal Order, animals may be moved from premises (including a licensed fat stock market) in an Infected Area to any slaughterhouse in any other Infected Area if accompanied by a licence of an Inspector of the Local Authority of the district in which the slaughterhouse is situate. No such licence shall be available for the movement of the animals unless and until it is countersigned by an Inspector of the Local Authority of the district from which the animals are to be moved.

Animals so moved shall be subject to the conditions as to movement, marking, and slaughter prescribed by the Principal Order in respect of animals being moved from a farm or licensed fat stock market in an Infected Area to a slaughterhouse in the same area.

## Short Title.

5. This Order may be cited as the GREAT BRITAIN (FOOT-AND-MOUTH DISEASE) ORDER OF 1923 (No. 11), and shall be read as one with the Principal Order.

In the administrative county of Lancaster.

The boroughs of Chorley and Widnes;

The petty sessional divisions of Kirkdale, Prescot, St. Helens (including its detached part), Warrington (except the parish of Rixton with Glazebrook), Southport, Ormskirk, Leyland Hundred, Leyland, and Walton le Dale; and

The parishes of Dalton, Upholland, Orrell, Billinge Higher End, Billinge Chapel End, Winstanley, Ashton-in-Makerfield, Lowton, and Kenyon (including any detached parts of such parishes); and

Also comprising:-

The city of Liverpool, and the county boroughs of Bootle, Warrington, Southport, and St. Helens.

## 12. An Area comprising:-

Such parts of the counties of Worcester, Hereford, and Monmouth including all county and other boroughs geographically situated therein as are not comprised within Infected Areas Nos. 6 and 11; and

In the administrative county of Salop.

The boroughs of Shrewsbury, Wenlock, Bridgnorth Ludlow, and Bishops Castle;

The petty sessional divisions of Clun and Purslow, Lower Munslow, Burford, Cleobury Mortimer, Brimstree, Shifnal, Wellington, Condover, Pontesbury, and Upper Munslow; and

The parishes of Uffington, Upton Magna, Ford, Alberbury with Cardeston, and Wollaston (including its detached part) and such part of the parish of St. Alkmond as lies to the south of the road No. 5062 together with the said road in so far as it divides the said parish.
