otherwise in such manner as the Council may consider best adapted for bringing these provisions to the notice of occupiers of land.

Offences.

6. Every person who fails to comply with the requirements of this Order or of any notice served under this Order or wilfully obstructs an Inspector in the exercise of his powers under this Order shall be liable on conviction to a penalty not exceeding ten pounds.

Application.

7. This Order shall apply to the Isles of Scilly.

Commencement and Short Title.

8. This Order shall come into operation on the first day of January, nineteen hundred and twenty-four, and may be cited as the BULB DISEASES (ISLES OF SCILLY) ORDER OF 1923.
