

employment on two day-shifts of women of 18 and young persons of 16 years of age and over in the Plating Department at the works of The British Thomson-Houston Co., Limited, Rugby, subject to compliance with the Welfare Order dated 12th October, 1917 (Ambulance and First Aid in Metal Works, etc.), and to the conditions that a worker shall not be employed in the afternoon shift for more than two consecutive weeks; that suitable cloakroom and messroom accommodation shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.
