ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 11TH DECEMBER, 1923.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows :-

Extension of Limits of Foot-and-Mouth Disease: Infected Places.

- 1. The Foot-and-Mouth Disease Infected Place described in the Schedule to the Order of the Minister, dated 29th November, 1923 (No. 1817), defining a Foot-and-Mouth Disease Infected Place, is hereby extended so as to include the fields known as New Turf, Wheats Meadow, Pits in the Middle and Old Seeds, being part of Church Farm, situated in the parish of Coppenhall, in the administrative county of Stafford, and in the occupation of William Henry Madders, Church Farm, Coppenhall, Staffordshire.
- 2. The Foot-and-Mouth Disease Infected Place described in the Schedule to the Order of the Minister dated 4th December, 1923 (No. 1874), defining a Foot-and-Mouth Disease Infected Place, is hereby extended so as to include the fields known as The Front Field and The Croft, being part of The Rowney Farm, situated in the parish of Tyrley, in the administrative county of Stafford, and in the occupation of James Sillito, The Rowney Farm, Market Drayton, Staffordshire.
