

ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

(DATED 11TH DECEMBER, 1923.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

*Extension of Limits of Foot-and-Mouth
Disease: Infected Place.*

The Foot-and-Mouth Disease Infected Place described in the Schedule to the Order of the Minister, dated 6th December, 1923 (No. 1906), defining a Foot-and-Mouth Disease Infected Place, is hereby extended so as to include the fields known as the Park Field and Waterlogs Field of The Outwoods Farm, situated in the parish of Great Packington, in the administrative county of Warwick, and in the occupation of Thomas Wilkinson Booth, The Outwood Farm, Great Packington, Coventry, Warwickshire.

FOOT-AND-MOUTH DISEASE:
INFECTED PLACES.

The several premises mentioned in the Schedule hereto are hereby declared to be places infected with Foot-and-Mouth Disease.

SCHEDULE.

Description and Limits of Infected Places.

1. The farmstead known as Yew Tree Farm, in the occupation of George Frederick

Bower, in the parish of Crowton, in the administrative county of Chester.

2. The land and buildings known as Church Farm, in the occupation of George Jennings, in the parish of Guilden Sutton, in the administrative county of Chester.

3. The land and buildings known as Barn Hill Lane Farm, in the occupation of Thomas Hughes, in the parish of Chowley, in the administrative county of Chester.

4. The farm and buildings known as Oakfields, in the occupation of William Garner, in the parish of Tattenhall, in the administrative county of Chester.

5. The land and buildings known as Poplar Hall Farm, in the occupation of John Nickson, in the parish of Hatton, in the administrative county of Chester.

6. The land and buildings known as Bebbington Farm, in the occupation of Charles Ryder, in the parish of Tattenhall, in the administrative county of Chester.

7. The fields and buildings known as Home Farm, in the occupation of Walter Davies, in the parish of Church Shocklach, in the administrative county of Chester.

8. The fields known as Near Old Field, New Hags Field and Cross Field, in the occupation of A. J. Shono, in the parish of Church Shocklach, in the administrative county of Chester.

9. All farm buildings and fields known as Pump House Farm, in the occupation of James Johnson, in the parish of Baddiley, in the administrative county of Chester.

10. The grass field known as Near Lightfoot Field, in the occupation of Lewis John Thomas Okell, in the parish of Barrow, in the administrative county of Chester.

11. The grass fields known as Marl Field, Wheat Field, Old Meadow, Nursery Bank, The Pastures, and Big Meadow, in the occupation of the Executors of Daniel Massey (Mary Massey, Manageress), in the parish of Bosley, in the administrative county of Chester.

12. All farm buildings and fields known as Bank Farm, in the occupation of John Hughes Babington, in the parishes of Wharton and Davenham, in the administrative county of Chester.

13. All farm buildings and fields known as Hill Top Farm, in the occupation of Sarah Howlett, in the parish of Darnhall, in the administrative county of Chester.

14. The land and buildings known as Broad Oak Farm, in the occupation of John Benson, in the parish of Tattenhall, in the administrative county of Chester.

15. The buildings and land known as Tattenhall Hall, in the occupation of Percy V. Cook, in the parish of Tattenhall, in the administrative county of Chester.

16. The buildings and land known as Tattenhall Lane, in the occupation of Mrs. Elizabeth Davenport, in the parish of Tattenhall, in the administrative county of Chester.

17. The land and buildings known as Cotton Hall, in the occupation of Robert Peacock, in the parish of Cotton Edmunds, in the administrative county of Chester.
