carcases of any animals so slaughtered shall after the deduction therefrom of the expenses of slaughter and disposal, be paid to the owner of the animals.

The Foot-and-Mouth Disease Infected Place (No. 13) described in the Schedule to the Order of the Minister, dated 4th December, 1923 (No. 1873), defining Foot-and-Mouth Disease Infected Places, is hereby extended so as to include the whole of the buildings and fields known as Coddington Hall, situated in the parish of Coddington, in the administrative county of Chester, and in the occupation of the Executors of the late Phillip Mottershead, Coddington Hall, Handley, Cheshire.

- 2. The Foot-and-Mouth Disease Infected Place (No. 13) described in the Schedule to the Order of the Minister, dated 14th December, 1923 (No. 2008), defining Foot-and-Mouth Disease Infected Places, is hereby extended so as to include the whole of the premises and fields known as Marsh House Farm, situated in the parish of King's Marsh, in the administrative county of Chester, and in the occupation of Major Philip Darning Holt, Sibbersfield Hall, Churton, near Chester.

The Foot-and-Mouth Disease Infected Place (No. 36) described in the Schedule to the Order of the Minister, dated 14th December, 1923 (No. 2008), defining Foot-and-Mouth Disease Infected Places, is hereby extended so as to include the field known as Nineacre Field and the two fields known as the Bridge Craft Fields, situated in the parish of Barton, in the administrative county of Chester, and in the occupation of Joseph Witter, Rock Farm, Barton, near Malpas, Cheshire.
