#### Extension of Limits of Foot-and-Mouth Disease : Infected Places.

1. The Foot-and-Mouth Disease Infected Place (No. 4) described in the Schedule to the Order of the Minister, dated 29th November, 1923 (No. 1807), defining Foot-and-Mouth Disease Infected Places, is hereby extended so as to include the fields known as Dutton's Fields, situated in the parish of Tilston, in the administrative county of Chester, and in the occupation of Robert Bourne, Pool Farm, Bickerton, near Malpas, Cheshire.

2. The Foot-and-Mouth Disease Infected Place (No. 5) described in the Schedule to the Order of the Minister, dated 14th December. 1923 (No. 2008), defining Foot-and-Mouth Disease Infected Places, is hereby extended so as to include the whole of the farm buildings, yards, and fields known as Yew Tree Farm, Hatherton, Nantwich, situated in the parish of Wybunbury, in the administrative county of Chester, and in the occupation of Albert Clifford Latham, Yew Tree Farm, Hatherton, Nantwich, Cheshire.

### ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

#### (Dated 14th December, 1923.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:

Now, therefore, I, Sylvanus Percival Vivian, Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:-

1. This Order may be cited as the West Derby and Liverpool Registration of Births, &c. Order, 1923, and shall come into opera-tion on the first day of January, 1924.
