

2.—(1) The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

(2) In this Order "existing," when used in relation to any area, means existing immediately before the operation of this Order.

3. The West Derby Western, Wavertree, and Much and Little Woolton Sub-districts of the West Derby Registration District shall cease to exist.

4.—(1) The Edge Hill, Kensington, and Low Hill Wards of the City of Liverpool shall form a new Sub-district of the Liverpool Registration District to be known by the name of the Edge Hill Sub-district.

(2) The Registrar of the existing West Derby Western Sub-district shall be the Registrar of the Edge Hill Sub-district of the Liverpool Registration District constituted by this Order.

5.—(1) The Aigburth, Allerton, Childwall, Garston, Wavertree, and Wavertree West Wards of the City of Liverpool shall form a new Sub-district of the Liverpool Registration District to be known by the name of the Wavertree Sub-district.

(2) The Registrar of the existing Wavertree Sub-district shall be the Registrar of the Wavertree Sub-district of the Liverpool Registration District constituted by this Order.

6.—(1) The Much Woolton and Little Woolton Wards of the City of Liverpool shall form a new Sub-district of the Liverpool Registration District to be known by the name of the Woolton Sub-district.

(2) The Registrar of the existing Much and Little Woolton Sub-district shall be the Registrar of the Woolton Sub-district of the Liverpool Registration District constituted by this Order.

7. The Superintendent Registrar of the existing Liverpool Registration District shall be the Superintendent Registrar of that Registration District as extended by this Order.

8.—(1) The existing Exchange Sub-district of the Liverpool Registration District shall be extended by the addition of the Scotland Sub-district of the same Registration District, and the extended Sub-district shall be known by the name of the Exchange Sub-district.

(2) The Registrar of the existing Exchange Sub-district shall be the Registrar of that Sub-district as extended by this Order.

9.—(1) The existing Toxteth Park South-West Sub-district of the Liverpool Registration District shall be extended by the addition of the Toxteth Park North-West Sub-district of the same Registration District, and the extended Sub-district shall be known by the name of the Toxteth Park West Sub-district.

(2) The Registrar of the existing Toxteth Park South-West Sub-district shall be the Registrar of the Toxteth Park West Sub-district constituted by this Order.

10.—(1) The Parishes of Aintree and Netherton shall be transferred from the Litherland Sub-district of the West Derby Registration District to the Fazakerley Sub-district of the same Registration District.

(2) The Crosby Sub-district of the West Derby Registration District shall be extended by the addition of the Litherland Sub-district as diminished by this Order and the extended Sub-district shall be known by the name of the Crosby Sub-district.

(3) The Registrars of the existing Fazakerley Sub-district and of the existing Crosby Sub-district shall respectively be the Registrars of those Sub-districts as extended by this Order.
