Now, therefore, His Majesty, by virtue of the power conferred on Him by sections thirteen and fourteen of the Air Force (Constitution) Act, 1917, and all other powers enabling Him in that behalf, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

1. The Air Force (Application of Enactments) (No. 1) Order, 1918, shall have effect as though the Schedule to that Order comprised the Schedule to this Order.

2. This Order may be cited as the Air Force (Application of Enactments) (No. 3) Order, 1923.

WHEREAS by Section 737 of the Merchant Shipping Act, 1894, it is provided that where under that Act, anything is authorised to be done by, to, or before, a British Consular Officer, and in any place outside His Majesty's Dominions in which His Majesty has jurisdiction there is no such Officer, such thing may be done in that place by, to, or before, such Officer as His Majesty in Council may direct:

And whereas the Merchant Shipping Act, 1894, has been from time to time amended by various Acts of Parliament, which Acts are construed as one with the Merchant Shipping Act, 1894, and may be cited together with the said Merchant Shipping Act, 1894, as the Merchant Shipping Acts, 1894 to 1928:

And whereas Nauru is a place outside His Majesty's Dominions in which His Majesty has jurisdiction, but in which there is no Consular Officer:

And whereas it has been made to appear to His Majesty that it is expedient that the officer hereinafter named should exercise and perform in the place aforesaid the powers and duties of a British Consular Officer under the Merchant Shipping Acts, 1894 to 1923:

Merchant Shipping Acts, 1894 to 1923: Now, therefore, His Majesty, by virtue of the power vested in Him by Section 737 of the Merchant Shipping Act, 1894, by and with the advice of His Privy Council, is pleased to direct as follows:—

(1) Anything which is, under the Merchant Shipping Acts, 1894 to 1923, authorised to be

done by, to, or before, a British Consular Officer may be done in Nauru by, to, or before the Officer for the time being acting as Administrator.

(2) This Order may be cited as the Merchant Shipping (Administration in Mandated Territories) No. 2 Order, 1923.
