WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 22nd day of November, 1923, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called 'the said Benefice') of Great Blakenham, in the County of Suffolk and in the Diocese of Saint Edmundsbury and Ipswich:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Great Blakenham is vested for an estate in fee simple without incumbrances in the Provost and Fellows of the College Royal of the Blessed Mary of Eton near unto Windsor (hereinafter called 'the Provost and

Fellows of Eton College '):

"And whereas the Provost and Fellows of Eton College are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Great Blakenham, now vested in them as aforesaid, should be transferred to and be vested in the Bishop of Saint Edmundsbury and Ipswich for the time being:

"And whereas the Right Reverend Walter Godfrey, now Bishop of Saint Edmundsbury and Ipswich, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that con-sent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Walter Godfrey, Bishop of Saint Edmundsbury and Ipswich, has executed hisSchemeas hereinafter mentioned:

" And whereas the transfer of the Patronage of the said Benefice of Great Blakenham which hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Great Blakenham:

"Now, therefore, with the consent of the Provost and Fellows of Eton College (in testimony whereof they have caused their Common Seal to be affixed to this Scheme), and with the consent of the said Walter Godfrey, Bishop of Saint Edmundsbury and Ipswich (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Great Blakenham, now vested in them, the Provost and Fellows of Eton College as aforesaid. shall be transferred to the said Walter Godfrey, Bishop of Saint Edmundsbury and Ipswich, and his successors in the same Bishopric, and shall thereupon and thenceforth pecome and be absolutely vested in and shall and may from time to time be exercised by the said Walter Godfrey, Bishop of Saint Edmunds-bury and Ipswich, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament
