FOOT-AND-MOUTH DISEASE (PROHIBI-TION OF HUNTING) ORDER OF 1923.

The Minister of Agriculture and Fisheries. by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows :-

Definition of Hunting.

1. In this Order "hunting" means the use of hounds, beagles, or other dogs, for the pur-

pose of hunting or coursing any deer, fox, otter, badger, hare, or other wild animal or vermin, or for hunting any drag trail.

Prohibition of Hunting, Coursing, and Whippet Racing in certain Areas.

2. Hunting, and the racing or training for racing or for coursing of any hounds or dogs is hereby prohibited in any Area which is for the time being declared to be a Prohibited, Infected, or Controlled Area, for the purposes of any Order of the Minister relating to Footand-Mouth Disease.

Offences.

3. Any person who uses any hounds, beagles, or other dogs for any purpose for which such use is prohibited by this Order shall be guilty of an offence against the Diseases of Animals Act, 1894.

Commencement.

4. This Order shall come into operation on the twenty-fourth day of December, nineteen hundred and twenty-three.

Short Title.

5. This Order may be cited as the FOOT-AND-MOUTH DISEASE (PROHIBITION OF HUNTING) Order of 1923.
