Formation of Further Infected Area.

1. The Foot-and-Mouth Disease (Infected Areas) Order of 1923 (No. 6), hereinafter referred to as the "Principal Order," shall be read and have effect as if the Area described in the Schedule to this Order were an Infected Area, described in the First Schedule to the Principal Order.

Revocation.

2. The Foot-and-Mouth Disease (Infected Areas) Order of 1923 (No. 7), is hereby revoked.

#### Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1923 (No. 8), and shall be read with the Principal Order.
