

APPOINTMENT OF STANDING FOR HACKNEY CARRIAGES CANCELLED.

By virtue of the Act 13 and 14 Victoria, chapter 7, intituled "An Act for consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of the Commissioners of Police of the Metropolis, and making other provisions in regard to the Consolidated Offices."

I, WILLIAM THOMAS FRANCIS HORWOOD, Commissioner of Police of the Metropolis, do hereby CANCEL the appointment of the Standing for twelve Hackney Carriages at Queen Street, Hammersmith, in four portions, viz. :—

First Portion.—Two Carriages by the kerb commencing four yards from the junction of Hammersmith Bridge Road.

Second Portion.—Three Carriages by the kerb commencing opposite Tramway Standard No. 139.

Third Portion.—Three Carriages by the kerb commencing six yards South of Tramway Standard No. 141.

Fourth Portion.—Four Carriages in centre of roadway, commencing opposite No. 39, Queen Street.

All vehicles to face North.

The first, second and third portions of the Standing to be fed exclusively by carriages from the second, third, and fourth portions respectively.
