WIMBLEDON.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Wimbledon (hereinafter called "the Corporation"), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter, or amend the Wimbledon Corporation Act, 1914, so as:—

(1) To enable the Merton and Morden Urban District Council to contribute to the cost of any works carried out by the Wimbledon Corporation under Section 77 of the said Act for the improvement of the Beverley Brook, and to borrow, with the sanction of the Minister of Health, such sum or sums as may from time to time be required for the purpose;

(2) To authorise the Merton and Morden Urban District Council to pay the costs of and incidental to the making and confirmation of such Provisional Order; and

(3) For the several purposes of the Application, or for purposes connected with, incidental to, or consequent on those purposes, to make any such alteration or amendment of the said Local Act, or of any other Local Act, or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given, that W. M. Cross, Esq., M.Inst.C.E., one of the Inspectors of the Ministry of Health, will attend at the Town Hall, Wimbledon, on Friday, the twenty-eighth day of March, 1924, at eleven o'clock in the forenoon, to hold a Local Inquiry into the subject-matter of the said Application and the proposed Provisional Order.

And notice is hereby further given, that any person interested may attend at such Inquiry and be heard with reference to the said Application and the proposed Provisional Order.
