#### ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES. (DATED 17TH APRIL, 1924.)

#### FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1924 (No. 63).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1922, and of every other power enabling him in this behalf, hereby orders as follows:—

#### Movement of Cattle and Sheep in Norfolk.

1. Notwithstanding the provisions of the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 34), hereinafter referred to as "the Principal Order "), or of the Foot-and-Mouth Disease (Infected Areas) Order of 1924 (No. 55) hereinafter referred to as "Order No. 55," cattle or sheep may be moved from premises situate in such part of the Infected Area No. 12, described in the First Schedule to Order No. 55 as is in the county of Norfolk to any premises in that county not included for the time being in any "Infected Area," subject to and in accordance with the following provisions of this Order, but not otherwise:—

(a) The animals shall be accompanied by a licence granted by the Clerk of the Local Authority of the county of Norfolk.

(b) Before any licence is granted under this Order the animals to be moved shall be examined by a Veterinary Inspector of the Local Authority of the county of Norfolk within forty-eighthours before the movement commences, and no licence shall be granted unless the animals have been certified by the Inspector to be free from any suspicion of Foot-and-Mouth Disease.

(c) The animals shall be moved as far as practicable by railway. The Clerk of the Local Authority may specify in the licence the routes by which the animals are to be moved to the railway station for the purpose of entraining, and from the railway station at which they are to be detrained to the place of  $\bar{c}$  estimation and may insert therein any other conditions which appear to him to be necessary or desirable to prevent the spread of disease.

(d) No licence shall be granted under this Order for the movement of animals from or to any premises situate within a radius of two miles from any place which is for the time being declared to be a place infected with Foot-and-Mouth Disease, and the route to be specified as aforesaid shall be such that at no point shall the animals be moved by road within a radius of two miles of any place which is for the time being declared to be a place infected with Footand-Mouth Disease.

(e) On arrival of the animals at the place of destination, specified in the licence, the animals shall be detained thereon for a period of 28 days. During that period the animals, and any other animals with which they have come in contact on the premises, shall be kept by the owner or person in charge thereof under his daily observation. No person shall enter the field, shed or other place where the animals are detained during the said period unless he is wearing suitable rubber boots. Every person upon leaving such field, shed or other place, shall thoroughly disinfect his hands and boots with one of the disinfectants specified in Article 2 (2) hereof.

#### Disinfection of Railway Trucks.

2.—(1) Every railway truck or other railway vehicle in which cattle or sheep are to be placed for the purpose of movement with a licence under this Order shall, not more than twenty-four hours before the animals are placed therein, be thoroughly sprayed or soused with liquid disinfectant under the supervision and to the satisfaction, of an Inspector of the Local Authority.

(2) The liquid disinfectant used for the purposes of this Article shall be:—

(a) a 1 per cent. (minimum) solution of chloride of lime (containing not less than 30 per cent. of available chlorine); or

(b) a 4 per cent. (minimum) solution of carbolic acid (containing not less than 95 per cent. of actual carbolic acid); or

(c) a disinfectant equal in disinfective efficiency to the above mentioned solution of carbolic acid.

(3) Nothing in this Article shall interfere with the operation of the provisions of the Animals (Transit and General) Order of 1912, or any Order amending that Order as to the cleansing and disinfection of railway trucks or other railway vehicles, used for the conveyance of animals on a railway.

#### Offences.

3. If any animal is moved, or anything is done or omitted to be done, in contravention of this Order or of the conditions of any licence granted thereunder, the owner and the person for the time being in charge of the animal in respect of which the same is done, or omitted to be done, or in respect of Article 2, the railway company carrying the animals, as the case may be, shall each according to and in respect of his or their own acts or omissions, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

To authorise the Corporation to open, break up and interfere with all streets, roads and public places, ways, footpaths, bridges, culverts, sewers, drains and gas and water mains and pipes and telegraph and telephone and other wires within the area of supply, and to lay down, erect, maintain, renew and remove, either above or under ground or otherwise, electric lines, conductors, mains, pipes, tubes, wires, posts, street or distributing boxes, meters, apparatus or other works or things required for the purpose of enabling the Corporation to generate, supply, store, convey, transmit or distribute electricity within the added area, and to confer all such other powers upon the Corporation as may be necessary for effecting the objects of the proposed undertaking.

7. To prescribe the maximum price or maximum prices that may be demanded and taken by the Corporation in respect of the supply of electrical energy within the added area.

8. To provide (if deemed expedient) for the transfer to the Corporation of so much of the undertaking of the Midland Electric Light & Power Company Limited under the Atherstone and District Electricity Special Order 1922 as is situate in or relates to the said parish of Hartshill Hamlet and for that purpose to alter amend or repeal so much of the said Order of 1922 as relates to that parish; or in the alternative to repeal or revoke some or all of the powers of the said Company to supply electricity within the said parish upon such terms as may be agreed between the Corporation and the Company or as may be specified in the Order.
