#### FACTORY AND WORKSHOP ACT, 1901.

The Secretary of State for the Home Department hereby gives notice, in pursuance of Section 80 of the Factory and Workshop Act, 1901, that he proposes to make new Regulations under Section 79 of the Act, in substitution for the Regulations dated 24th October, 1904, for the processes of loading, unloading, moving and handling goods in, on, or at any dock, wharf, or quay, and the processes of loading, unloading and coaling any ship in any dock, harbour, or canal.

Copies of the Regulations proposed to be made may be obtained on application to the Chief Inspector of Factories, Home Office, London, S.W. 1.

Objections to the draft Regulations by or on behalf of any persons affected by the Regulations must be sent to the Secretary of State, Home Office, London, S.W. 1, within 30 days from the date of this notice. Every such objection must be in writing and must state (a) the draft Regulations or portions of draft Regulations objected to; (b) the specific grounds of objection; and (c) the omissions, additions or modifications asked for.

#### APPOINTMENT OF STANDING FOR HACKNEY CARRIAGES WITHIN THE METROPOLITAN POLICE DISTRICT, AND REGULATIONS TO BE OBSERVED.

*By virtue of the Act 13 and 14 Victoria, chapter 7, intituled "An Act for consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis and making other provisions in regard to the Consolidated Offices."*

I, WILLIAM THOMAS FRANCIS HORWOOD, Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for fourteen Hackney Carriages at Drewstead Road, Streatham Hill, in two portions, and do made the following Regulations with regard to the Boundaries for the same, viz. :—

*First Portion.*—Two Carriages on North side of roadway, commencing 3 yards West from foot crossing in High Road, extending Westward as far as necessary for two carriages.

Front of vehicles toward the East.

NOTE.—Of the two carriages on this portion, one shall be mechanically propelled, and the other horse drawn.

*Second Portion.*—Twelve Carriages on North side of roadway, commencing at a point in line with the entrance to Stonehills Mansions, extending Westward as far as necessary for twelve carriages.

Front of vehicles toward the East.

The First portion of the Standing to be fed exclusively by carriages from the second portion.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriageway, or upon any place where foot passengers usually cross the carriageway.
