The General Minimum Piece-Rates and Overtime Rates for Female Workers employed on Hessian Weaving in the Areas of Aberdeen, Barrow-in-Furness, Dundee and Tayport, set out in the Trade Boards Notice J. (29) dated 8th June, 1923, in their application to Double Loom Weavers, are varied as follows:—

- (a) the STANDARD (FENERAL MINI-MUM PIECE-RATE for Double Loom Weavers set out in Section I (b) of Part I of the Notice J. (29) is 15 per cent. less than the Standard General Minimum Piece-Rate for Single Loom Weavers, (instead of 20 per cent. less as formerly provided in that Notice);
- (b) the other General Minimum Piece-Rates for Double Loom Weavers specified in the Notice J. (29) shall be calculated in the manner provided in that Notice on the basis of the Standard General Minimum Piece-Rate as varied; and

(c) the Overtime Rates for Double Loom Weavers shall be calculated in the manner provided in Part III of the Notice J. (29) on the basis of the General Minimum Piece-Rates as varied.

This notice J (33) must be posted up and read in conjunction with the Notice J (29) issued by the Jute Trade Board (Great Britain).

Signed by Order of the Trade Board and in pursuance of an Order of the Minister of Labour confirming the Minimum Rates of Wages as varied by the Trade Board and set out above, and specifying the 26th May, 1924, as the date from which they should become effective.
