The KING has been pleased to give and grant unto Captain George Napier Tomlin, C.M.G., M.V.O., R.N., His Majesty's Royal licence and authority to wear the Insignia of the Second Class of the Order of Al Merito, which Decoration has been conferred upon him by the President of the Republic of Chile in recognition of valuable services rendered by him while lent to the Chilean Navy.

The KING has been pleased to give and grant unto Captain John Patrick Shelley, The King's Own Royal Regiment (Lancaster), His Majesty's Royal licence and authority to wear the Insignia of the Fourth Class of the Order of the Nile, which Decoration has been conferred upon him by His Majesty the King of Egypt, in recognition of valuable services rendered by him while employed with the Egyptian Army.

The KING has been pleased to give and grant unto William Verner Barry, Esq., and William Edward Twist, Esq., His Majesty's Royal licence and authority to wear the Insignia of the Fifth Class of the Order of the Nile, which Decorations have been conferred upon them by His Majesty the King of Egypt, in recognition of valuable services rendered by them as officials of the Sudan Government.

The KING has been pleased, by Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland bearing date the 23rd instant, to confer the dignity of a Viscount of the said United Kingdom upon Freeman, Baron Willingdon, G.C.S.I., G.C.I.E., G.B.E., and the heirs male of his body lawfully begotten, by the name, style and title of Viscount Willingdon, of Ratton, in the County of Sussex.

The Home Secretary gives notice that, in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day shifts of women of 18 and young persons of 16 years of age and over in spinning, reeling, bleaching and drying, and sorting at the works of Messrs. Harbens (Viscose Silk Manufacturers) Limited, Parkside Mills, Golborne, near Warrington, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks; that suitable cloakroom and messroom accommodation, washing facilities and facilities for sitting shall be provided; that a responsible forewoman shall be appointed on each shift, who shall be charged with the supervision of the women and young persons employed, and shall also be in charge of the messroom, cloakroom and other welfare arrangements; and that the Secretary of State
