MALDON, WIVENHOE AND CLACTON DRAINAGE DISTRICT (ESSEX).

Extension of Area.

Notice is hereby given, that the Ministry of Agriculture and Fisheries has settled and made an Order under the Land Drainage Act, 1918, extending the area of the above Drainage District by the addition thereto of approximately 200 acres of land lying to the East of the present District, and that the Order will become final and have effect as an Act of Parliament, unless within thirty days from the date of this Notice a memorial that the Order shall not become law without confirmation by Parliament is presented to the Ministry by some person or body affected by the Order and having such interest as is prescribed by Article 4 of the Land Drainage Regulations, 1918 (Statutory Rules and Orders, 1918, No. 1605), as being sufficient for the purpose.

SALMON AND FRESHWATER FISHERIES ACT, 1923.

To Owners and Lessees of Fisheries, Salmon and Trout Licensees and other persons interested.

Whereas the Coquet Fishery Board have applied to the Minister of Agriculture and Fisheries for an Order under Part IV of the above-mentioned Act to provide for:—

(a) Increasing the number of members that may be appointed by the council of the administrative county of Northumberland to twenty;

(b) Modifying in relation to the fisheries of the Coquet Fishery District the provisions of Sections 50 (1) (b) and 59 (1) (a) and (d) of the Act.
