The following Statute made by the Governing Body of Sidney Sussex College, Cambridge, on the 2nd day of June, 1924, and sealed by the University of Cambridge Commissioners on the 4th day of August, 1924, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

Whereas Sidney Sussex College in the University of Cambridge is now governed by a body of Statutes made under the authority of "The Universities of Oxford and Cambridge Act 1877," and approved by His Majesty the King in Council on the twenty-first day of April one thousand nine hundred and twenty two.

And whereas it is expedient for the good administration of the College that the Statutes now in force should be amended and altered and that certain Statutes should be added.

And whereas section eleven of the Schedule to "The Universities of Oxford and Cambridge Act 1923" confers upon the Governing Body of the College until the end of the year one thousand nine hundred and twenty four the like powers in all respects of making Statutes for the College and of making Statutes for altering or repealing Statutes made by them as are from and after the end of that year conferred by that Act on the Commissioners

appointed by that Act subject to the approval of the said Commissioners by writing under their seal.

Now we the Master and Fellows of the said College being the Governing Body within the meaning of the said last mentioned Act being assembled at a meeting of the Master and Fellows of the said College specially summoned for this purpose on the second day of June one thousand nine hundred and twenty four do hereby in exercise of the powers conferred upon us by the eleventh section of the Schedule to the said last mentioned Act and of all or any other powers therein enabling us amend and add to the said Statutes by the amending and additional Statute following which has been passed at such meeting by the votes of more than two-thirds of the persons present and voting and is now submitted for the approval of the said Commissioners and if approved by them for the further approval of His Majesty the King in Council.

## CHAPTER X (a).

### *Retirement and Pension of Officers.*

(1) When any Fellow not holding nor having held any of the following College Offices viz.: Master Tutor Assistant Tutor College Lecturer Bursar or Dean (hereinafter called "the pensionable offices") shall after the date of the making of these Statutes be appointed to some or one of the pensionable offices he shall forthwith become subject to the terms of the Federated Superannuation System for Universities hereinafter called "the Superannuation
