

County of Lancaster to the West Riding of the County of York by the Local Government Act, 1888, 51 & 52 Vict. c. 41; the County of Chester (except that portion which includes the parishes of Church Lawton, Odd Rode and Wildboarclough, and the portion situated on the east side of the North Staffordshire Railway from Mow Cop Station to North Rode Station, and south of the North Staffordshire Railway from North Rode Station to Rushton Station); the Counties of Flint, Denbigh, Montgomery, Merioneth, Carnarvon and Anglesey.

No. 6 or Cardiff and Newport Division, consisting of the County of Monmouth; so much of the County of Glamorgan as includes the parishes of Aberdare, Rhondda, Llantrisant, Coychurch Higher, Pencoed, Coychurch Lower, Llan-Gan, Colwinston, Llandow and St. Donats, and all parishes to the East thereof; so much of the County of Brecon as includes the parishes of Llyswen, Llandefalle, Llanfilo, Llan-y-wern, Llanhamlach, Llanfrynach, Cantref, Penderyn and all parishes to the East thereof; the Counties of Radnor and Cardigan.

No. 7 or Swansea Division, consisting of the Counties of Carmarthen, Pembroke, West Glamorgan (namely, that part of the County of Glamorgan not included in the Cardiff and Newport Division), and West Brecon (namely, that part of the County of Brecon not included in the Cardiff and Newport Division).

No. 8 or Midland and Southern Division, consisting of so much of the County of Chester as is not included in the Lancashire and North Wales Division, and the Counties of Stafford, Salop, Worcester, Warwick, Hereford, Gloucester, Northampton, Rutland, Huntingdon, Cambridge, Oxford, Berks, Buckingham, Bedford, Hertford, Middlesex, Norfolk, Suffolk, Essex, Somerset, Devon, Cornwall, Dorset, Wilts, Southampton, London, Surrey, Sussex, and Kent.

2. The Mines Inspection Divisions Order of the 23rd April, 1913, is hereby revoked.

3. This Order may be cited as the Mines and Quarries (Inspection Divisions) Order, 1924, and shall come into force on the First day of September, 1924.
