ASHFORD ELECTRICITY.

THE Urban District Council of Ashford (hereinafter referred to as "the Council ") whose address is at the Council Offices, Ashford, in the County of Kent, have applied to the Electricity Commissioners under the Electricity (Supply) Acts 1882 to 1922 for a Special Order for the following objects:—

(a) To authorise the Council to generate, transform and distribute electrical energy for all public and private purposes as defined by the above Acts within the Urban District of Ashford, the Rural District of East Ashford and the Rural District of West Ashford (hereinafter referred to as "the area of supply");

supply ''); (b) To authorise the Council on the lands hereunder described to erect construct maintain work and use a station or stations together with all such buildings works and other plant, machinery and apparatus as may be suitable or necessary for generating electricity (that is to say):—

A piece of land situate in the urban district of Ashford in the county of Kent containing 2.6 acres or thereabouts being the south western portions of the enclosures numbered 269 and 270 on the 2500 Ord-nance Map Kent Sheet LXV. 5 (Edition 1907) belonging or reputed to belong to the Southern Railway Company bounded on the north-east by the remainder of the said enclosures on the south-east by a footpath leading from the cattle market to Jemmett Road on the south-west by a piece of land belonging or reputed to belong to Dorothy Elizabeth Cotterell and numbered 271 on the said map and on the north-west by Gasworks Lane which said piece of land is coloured pink on the plan deposited in relation thereto at the office of the Electricity Commission.

(c) To provide that the powers of the Kent Electric Power Company and the South East Kent Electric Power Company Limited respectively to supply electrical energy in any part of the area of supply shall be limited to giving supplies of electrical energy for power purposes and (where any such supply is given to any premises) for lighting purposes to an extent to be prescribed in the Order and to provide further that neither of those Companies shall supply electrical energy in the area of supply without the consent of the Council or to make such other provisions for the restriction of or partial repeal of the respective powers of those Companies as may be deemed expedient.

(d) To empower the Council to sell electric lines, fittings, apparatus and appliances for lighting, heating and motive power and for all other purposes for which electricity can be used, and to fit up show-rooms and offices and exhibit specimen installations and give demonstrations of the uses to which electrical energy can be put.

(e) To authorise the Council to exercise within the area of supply the powers usually conferred on distributors of electrical energy.
2. The names of the streets and parts of streets in which electrical lines are to be laid down within a specified time are as follows:—

(A) In the urban district of Ashford--

New Street, High Street, East Hill, Hythe-Road, Maidstone Road from Chart Road to a point opposite Highworth, Magazine Road from New Street to Queen's Road, Queen's Road, Albert Road, North Street, Canterbury Road, Gore Hill from Magazine Road to a point opposite Gore Hill House Wellesley Road from High Street to Somerset Road, Western Avenue, Godinton Road from Western Avenue to Gasworks Lane, Gasworks Lane, Bank Street, Elwick Road, Station Road, Dover Place, Victoria Road, Beaver Road from Railway Station to Christchurch Road, Christchurch Road, Jemmett Road, Rising Road and Hill Brow Road.

(B) In the parish of Willesborough—

Hythe Road from the boundary between the urban district of Ashford and the parish to Albemarle Road.
