Corporation annually such sum not exceeding five shillings as the Corporation may from time to time determine for or towards the maintenance repair and renewal by them of such ashbins; such payment to be in satisfaction of the obligations of such owners or occupiers in regard to such maintenance repair and renewal; and

(6) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Acts or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the

said Application;

NORTH WEST MIDLANDS ELECTRICITY

DISTRICT.

REORGANISATION OF ELECTRICITY SUPPLY IN FARTS OF THE COUNTIES OF CHESTER, SALOP AND STAFFORD.

Whereas the Electricity Commissioners, by notice dated the 10th day of September, 1920, provisionally determined that a certain area, comprising parts of the Counties of Chester, Derby, Salop and Stafford, should be constituted a separate Electricity District under the name of "the North West Midlands Electricity District":

And whereas the Electricity Commissioners, as the result of a Local Inquiry into a scheme submitted to them for effecting an improvement in the existing organisation for the supply of electricity in the District, have decided to exclude from the said District as provisionally determined certain areas in the northern portion thereof, and have published a scheme which they have approved in respect of certain areas in the southern portion of the District to be known as the West Midlands Electricity District:

And whereas the Electricity Commissioners have decided that certain of the aforesaid excluded areas in the northern portion of the

North West Midlands Electricity District as provisionally determined should be constituted a separate electricity district under the name of the North West Midlands Electricity District:

Now therefore notice is hereby given that the Electricity Commissioners have provisionally determined that the under-mentioned area shall be constituted a separate Electricity District for the purposes of the Electricity (Supply) Act, 1919, that is to say:—

The County Borough of Stoke-on-Trent;

So much of the Administrative County of Chester as comprises:—

The Municipal Borough of Congleton; The Urban District of Buglawton;

So much of the Administrative County of Salop as comprises:—

The Urban District of Market Drayton; The Rural District of Drayton;

So much of the Administrative County of Stafford as comprises:—

The Municipal Boroughs of Newcastleunder-Lyme and Stafford;

The Urban Districts of Audley, Biddulph, Kidsgrove, Leek, Smallthorne, Stone, Uttoxeter and Wolstanton United;

The Rural Districts of Blore Heath, Cheadle, Gnosall, Leek, Mayfield, Newcastle-under-Lyme, Stafford, Stoke-on-Trent, Stone, Uttoxeter (excluding the detached portion thereof situated in the Rural District of Tutbury), and all the detached portions of the Rural District of Tutbury, situated within the Rural District of Uttoxeter,

which area is more particularly delineated on a Map which is available for public inspection at the County Offices, Chester; the Shire Hall, Shrewsbury; the County Buildings, Stafford; the Town Hall, Congleton; the Town Hall, Stoke-on-Trent; the Town Hall, Newcastleunder-Lyme; the Town Hall, Stafford; the Urban District Council Offices, Market Drayton; the Urban District Council Offices, Leek; the Urban District Council Offices, Stone; and the Urban District Council Offices, Uttoxeter.

Objections and Representations may be made on account of the inclusion of any area in, or the exclusion of any area from, the District so provisionally determined, and all such Objections or Representations must be made in writing addressed to The Secretary, Electricity Commission, Gwydyr House, Whitehall, London, S.W. 1, stating the grounds upon which the Objections or Representations are made, and must reach the said Offices of the Commissioners not later than the twenty-eighth day of February, 1925. Any such Objection or Representation should state: (a) The area or part of the area in respect of which the Objection or Representation is made, described in terms of the Local Government Boundaries, and shown on an Ordnance map on a scale of one inch to the mile; (b) The omission or addition desired, and the specific grounds for exclusion or inclusion; and, in the case of any area proposed to be excluded from the district, should specify any alternative proposal for any improvement in the organisation of the supply of electricity in such area.
