"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Biscot is vested for an estate in fee simple in Joan Crawley, of Stockwood Park, Luton, in the said County of Bedford, Spinster, subject, however, together with other hereditaments to certain family charges but otherwise free from incumbrances:

" And whereas the said Joan Crawley is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Biscot, now vested in her as aforesaid, should be transferred to and be vested in the Bishop of Saint Albans for the time being:

" And whereas the Right Reverend Michael, now Bishop of Saint Albans, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Michael, Bishop of Saint Albans, has executed this Scheme as hereinafter mentioned:

' And whereas the transfer of the Patronage of the said Benefice of Biscot which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the New Parish of Biscot:

Now, therefore, with the consent of the said Joan Crawley (in testimony whereof she has signed and sealed this Scheme), and with the consent of the said Michael, Bishop of Saint Albans (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and pre-sentation to the said Benefice of Biscot, now vested in her, the said Joan Crawley as aforesaid, shall be transferred to the said Michael, Bishop of Saint Albans, and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Michael, Bishop of Saint Albans, and by his successors in the same Bishopric for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the previsions of the said Acts, or of any of them, or of any other Act of Parliament.'

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Saint Albans.

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure of Brompton with the Chapelry of Snainton annexed (hereinafter called the said Benefice of Brompton with Snainton '), in the County of York and in the Diccese of York:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Brompton with Snainton is now limited and settled to uses under which Sir Kenelm Henry Ernest Cayley, Baronet, of The Hall, Brompton by Sawdon, in the said County of York, is tenant for life thereof subject, however, together with other hereditaments to a jointure charge in favour of Lady Mary Susan Cayley, of The Hall, Brompton by Sawdon aforesaid, Widow, but otherwise free from incumbrances, and the said Kenelm Henry Ernest Cayley is therefore the Patron or person entitled to present or nominate to the said Benefice in case the same were now vacant:

"And whereas the said Kenelm Henry Ernest Cayley is desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Brompton with Snainton should be transferred to and be vested in the Archbishop of York for the time being, and the said Mary Susan
