The funds also are held in trust in the names of two Trustees, who are both living, under a Deed of Trust, duly executed and approved by your Committee and in accordance with the terms of such Deed. All the information we required has been supplied to us, and so far as our examination of the Books has gone, they appear to have been properly kept.
