Once the summons has been issued, the amending of a summons card in order to include a lady's husband can only be permitted under the most exceptional circumstances.

#### COUNTY COURT DISTRICTS.

I, George Viscount Cave, Lord High Chancellor of Great Britain, by virtue of section 4 of the County Courts Act, 1888, as amended by section 9 of the County Courts Act, 1924, and of all other powers enabling me in this behalf, do hereby order as follows:—

1. The District of the County Court of Rutland held at Uppingham, except the Parishes detached therefrom by paragraph 3 hereof, shall be consolidated with the District of the County Court of Lincolnshire held at Stamford, and the holding of the said Court held at Uppingham shall be discontinued, and the said Court held at Stamford shall be the Court for the District formed by the said consolidation, and shall have jurisdiction to deal with all proceedings which shall be pending in the said Court held at Uppingham when this Order comes into operation.

2. The County Court of Surrey held at Guildford and Godalming shall cease to be held at Godalming, and shall be held at Guildford by the name of the County Court of Surrey

held at Guildford.
3. The Parishes set out in the first column of the Schedule to this Order shall be detached from and cease to form part of the Districts set opposite to their names respectively in the second column of the said Schedule, and shall be transferred to, and form part of, the Districts set opposite to their names respectively in the third column thereof.
4. In this Order "Parish" shall have the

same meaning as in the County Courts (Districts) Order in Council, 1899, provided that the boundaries of every Parish mentioned in this Order shall be those constituted and limited

at the date of this Order.

5. This Order may be cited as the County Court Districts (Miscellaneous No. 1) Order, 1924, and shall come into operation on the 1st day of January, 1925, and the County Courts (Districts) Order in Council, 1899, as amended, shall have effect as further amended by this Order.

#### TENDERS FOR TREASURY BILLS AND TREASURY BONDS.

- 1. The Lords Commissioners  $\mathbf{His}$ of Majesty's Treasury hereby give notice, that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 2nd January, 1925, at 1 o clock, for :-
  - (a) Treasury Bills to be issued under the Treasury Bills Act, 1877, The National Debt Act, 1889, and the War Loan Acts, 1914-1919; and
  - (b) £4 per cent. Treasury Bonds, repayable at par on the 15th April, 1933.
- 2. The maximum amount of Treasury Bills and Treasury Bonds to be issued will be £40,000,000. The amount of Treasury Bonds issued will not exceed £4,000,000, but subject to that limit the total amount issued will be divided between Bills and Bonds in such proportions as Their Lordships may determine.

The Bonds will be in denominations of £50, £100, £200, £500, £1,000 and £5,000 They will be exempt from Corporation Profits Tax, and will, as indicated in the Notice of September, 1924, rank pari passu with those issued under the Prospectus of the 23rd March, 1923. They will be dated at the 3. The Bills will be in amounts of £5,000 or £10,000. #### NATIONAL DEBT.

GOVERNMENT STOCK (REDEMPTION).

#### REGULATIONS.

The Treasury, in pursuance of the powers conferred upon them by the Third Schedule to the Finance Act, 1921, and of all other powers enabling them in that behalf, hereby make the

following Regulations:—
1.—(1) These Regulations may be cited as the Government Stock (Redemption) Regu-

lations, 1924.

(2) In these Regulations the expression person of unsound mind "includes a person who through mental infirmity arising from disease or age is incapable of managing his affairs, and the expression "committee" includes a quasi-committee.

(3) The Interpretation Act, 1889, applies for the purpose of the interpretation of these Regulations as it applies for the purpose of the interpretation of an Act of Parliament.

2.—(1) Where any principal moneys become payable on the redemption of any Government stock standing in the name of a stockholder who is a person of unsound mind, or an infant, or a person otherwise under disability, the committee, the guardian, or the person having power in law to administer the property of the stockholder may by notice in writing give to the Bank on behalf of the stockholder direc-

tions for the reinvestment of those moneys in such Government stock as may be specified in the directions.

(2) Where any directions for reinvestment are given under this Regulation, the Bank shall cause any Government stock purchased in pursuance of the directions to be transferred into the name or names in which the redeemed stock was standing in the books of the Bank

at the date of redemption.

3. Any order or decree of any court in Great Britain or Northern Ireland whereby the right to receive any principal moneys which become payable on the redemption of any Government stock standing in the name of any stockholder (whether as sole stockholder or jointly with any other person) who is a person of unsound mind, or an infant, or a person otherwise under disability, is vested in any person as com-mittee or guardian of the stockholder or otherwise, shall be sufficient authority to the Bank to pay the principal moneys to that person in accordance with the order or decree.

4. Nothing in these Regulations shall be taken to prejudice the right of the Bank to require evidence to be given to their satisfaction to prove that any person purporting to give directions under these Regulations is a person having power thereunder to give such directions, or that a person claiming to be paid any moneys under these Regulations is a person to whom the payment may properly be made thereunder, and with respect to matters

incidental to such proof.

5.—(1) An official extract of any such appointment as is mentioned in Section 13 of the Judicial Factors (Scotland) Act, 1889, shall, in any case where any Government stock is specified in the extract, or in a certificate under seal by the accountant of court produced together with the extract, as belonging to or forming part of the estate under the charge of the person named in the extract, be deemed for the purpose of these Regulations to be a decree whereby the right to receive the principal moneys becoming payable on the redemption of that stock is vested in the person so named.

(2) In the application of these Regulations to Scotland the expression "infant" includes pupil or minor and the expression "guardian" includes tutor or curator.

MOTOR CAR ACT, 1903.

SECTION 9.

CITY OF OXFORD.

To the Mayor, Aldermen and Citizens of the City of Oxford;—

And to all others whom it may concern.

Whereas by sub-section (1) of Section 9 of the Motor Car Act 1903 (hereinafter referred to as "the Act") it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour.

And whereas by sub-section (3) of the said section the Local Government Board were empowered to revoke or alter any regulation made by them under the said section.

And whereas the power to make revoke or alter such Regulations has been transferred to the Minister of Transport.

And whereas on the Twelfth day of September in the year One Thousand Nine Hundred and Ten the Local Government Board made Regulations in pursuance of the said subsection (1) declaring that the provisions of the said sub-section with respect to the driving of a motor car at a speed not exceeding ten miles per hour should apply and have effect within the limits comprising the roads within the City

of Oxford specified in the Schedule to the said Regulations and including Botley Road (otherwise Seven Bridges Road).

And whereas the Town Council of the City of Oxford have represented to the Minister of Transport that the said Regulations so far as they apply to the part of the said Botley Road hereinafter described, should be revoked.

Now therefore the Minister of Transport, in pursuance of the powers given to him in that behalf, hereby revokes the said Regulations made on the Twelfth day of September in the year One Thousand Nine Hundred and Ten by the Local Government Board as from the first day of January One Thousand Nine Hundred and Twenty-five so far as they apply within limits comprising that part of Botley Road which extends from Binsey Lane to the City Boundary: Provided that the said Regulations shall remain of full force and effect within limits comprising all the roads specified in the Schedule thereto except the part of Botley Road hereinbefore described.

HARBOURS, DOCKS AND PIERS (TEMPORARY INCREASE OF CHARGES) ACTS, 1920 to 1922.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Destructive Insects and Pests Acts, 1877 and 1907, and of every other power enabling him in this behalf, orders as follows:—

#### Prohibition of Importation of Potatoes.

1. For the prevention of the introduction of the Colorado Beetle, the landing in England or Wales of any potatoes grown in the United States of America is hereby prohibited.

#### Commencement.

2. This Order shall take immediate effect, provided that this Order shall not be deemed to prevent the landing of potatoes shipped from the United States of America before the date of this Order.
