A. Lodging, except in any case in which the Wages Committee shall have determined that the lodging accommodation provided is so defective as to be injurious to health.

B. Board, including any meals, but not including intoxicating drink.

2. The value at which the said benefits and advantages are to be reckoned are hereby defined as follows:—

Board and Lodging for male workers of 21 years of age and over for a 7-day week, 16s.

#### ORDER DEFINING THE EMPLOYMENT TO BE TREATED AS OVERTIME EMPLOYMENT.

The Shropshire Agricultural Wages Committee, in pursuance of the powers vested in them by the Agricultural Wages (Regulation) Act, 1924, and the Agricultural Wages Committees Regulations, 1924, do by this Order define the under-mentioned employment as the employment which is to be treated as overtime employment for the purpose of the application of any differential rate of wages for overtime fixed by the said Committee in the area comprising the administrative county of Salop:

1. *In the case of male workers* (except as provided in clause 3 below):—

(a) All employment after 1 p.m. on a Saturday, or on such other day (not being Sunday) in every week as may be agreed between employer and worker, except in any case in which the total hours worked during the week (excluding Sunday) are less than 54.

(b) All employment on a Sunday.

(c) All employment in excess of 54 hours in any week (excluding all hours which are treated as hours of overtime employment).

2. *In the case of female workers*:—

All employment on a Sunday.

3. *In the case of male workers* of 21 years of age and over employed on the Hay or Corn harvests:—

(a) All employment after 1 p.m. on a Saturday, or on such other day (not being Sunday) in every week as may be agreed between employer and worker.

(b) All employment on a Sunday.

(c) All employment on any other day after 6 p.m.
