

9. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills or Bonds are to be dated.

10. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills and Bonds.

11. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

12. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

# RULES OF SUMMARY PROCEDURE OF THE ANGLO-GERMAN MIXED ARBITRAL TRIBUNAL CONSTITUTED UNDER ARTICLE 304 OF THE TREATY OF VERSAILLES.

A. In any claim or case presented to the Tribunal written notice may be given to the Secretariat by either Government Agent or any party that he desires the claim or case to be dealt with under the Tribunal's Rules of Summary Procedure. Such notice is hereinafter referred to as a Summary Notice.

In the case of joint Claimants or Respondents or joint Creditors or Debtors a Summary Notice given by one of them will be deemed sufficient.

B. A Summary Notice may be given at any stage of the proceedings, but shall not be given after the respective Government Agents and the parties have received notice of the fixing of a date of hearing.

C. When a Summary Notice shall have been delivered to the Tribunal the Secretariat will forthwith cause a notification thereof to be forwarded to the Government Agent of each party. Such Government Agent shall acknowledge the receipt thereof to the Secretariat, and shall effect service of the Notice on the party referred to, and shall forthwith notify the Tribunal of such service and of the date thereof.

D. When a Summary Notice shall have been given any party or either Government Agent may within 21 days of the notification to him of the Summary Notice, forward to the Tribunal an objection in writing stating that he objects to the claim or case being dealt with under the Rules of Summary Procedure and the grounds of his objection.

E. When a new party has been joined in the proceedings after a Summary Notice has been given, the Secretariat will forthwith cause a notification of such Summary Notice to be forwarded to the new party in accordance with Rule C at his address for service or through his Government Agent. Such new party shall have the right within 21 days of the notification to him of the Summary Notice to forward to the Secretariat an objection in writing stating that he objects to the claim or case being dealt with under the Rules of Summary Procedure and the grounds of his objection.

F. In a case under paragraph 16 of the Annex to Article 296 of the Treaty, the Tribunal will on receipt of notice of objection in accordance with Rule D or E, consider the grounds of objection and determine whether the case shall be dealt with under the Rules of Summary Procedure. In any other claim or case the receipt of notice of objection in accordance with Rule D or E shall be sufficient to prevent the application to the claim or case of the Rules of Summary Procedure.
