WHEREAS the majority of the whole Council of the Borough of Hythe on the twelfth day of February, 1924, agreed to petition, and the Council of the said Borough thereupon petitioned His Majesty under and in pursuance of the provisions of Section 30 of the Municipal Corporations Act, 1882, as amended by Section 2 of the Municipal Corporations Act, 1893, for an alteration of the Boundaries of the Wards of the said Borough:

And whereas His Majesty was pleased by His Order in Council of the 20th day of February, 1924, to refer the said Petition of the Council of the Borough of Hythe to a Committee of His Privy Council:

And whereas His Majesty was pleased by His Order in Council of the 16th day of April, 1924, to approve the Report of the said Committee, to the effect that, no Petition having

been presented against a compliance with the prayer of the said Petition of the said Council of the Borough of Hythe, within the time limited by Statute in that behalf, it rested with the Secretary of State to appoint a Commissioner in accordance with the provisions of the said Section 30 of the Municipal Corporations Act, 1882, to prepare a Scheme for the carrying into effect the prayer of the said Petition:

And whereas The Right Honourable Arthur Henderson, one of His Majesty's Principal Secretaries of State, did by warrant, given under his hand and seal at Whitehall, on the 14th day of July, 1924, appoint James Benjamin Melville, Esquire, Barrister-at-Law, a Commissioner to prepare a Scheme for carrying into effect the prayer of the said Petition:

And whereas the said Commissioner has, in pursuance of the powers given him by virtue of the said appointment, prepared the following Scheme dated the 27th day of January, 1925, accordingly:—

“ BOROUGH OF HYTHE.

“ SCHEME for determining the Boundaries of, and for apportioning the Councillors among the WARDS of the Borough of Hythe.

“ (1) NUMBER OF WARDS.

“ Under the Hythe Improvement and Waterworks Act, 1874, (37 & 38 Vict., ch. LXVI.), section 15 the number of the wards of the said Borough was fixed at four.

“(2) NOMENCLATURE OF WARDS.

1. North Ward.
2. East Ward.
3. West Ward.
4. South Ward.

“(3) BOUNDARIES OF WARDS.

“(1) *North Ward.*

“Commencing at a point in the centre of the Ladies Walk Bridge and thence Westwards along the centre of the Royal Military Canal to the Borough Boundary at West Hythe thence following the line of the Borough Boundary Northward and Eastward to a point in the centre of the Road at the top of Tanner's Hill thence Southward along the centre of Tanner's Hill to the intersection of Dental Street thence Westward along the centre of Dental Street to the intersection of Market Hill thence Southward along the centre of Market Hill to the intersection of High Street thence Southward along the centre of Marine Walk Street to the intersection of Prospect Road thence Southward in a straight line through the Grove to the point of commencement aforesaid.

“(2) *East Ward.*

“Commencing at a point in the centre of the Ladies Walk Bridge and thence Eastwards along the centre of the Royal Military Canal to the Borough Boundary at Seabrook thence following the line of the Borough Boundary Northward and Westward to the Boundary of the North Ward in the centre of Tanner's Hill and thence Southward and Westward and again Southward along the Eastern and South Eastern boundaries of the North Ward as herebefore defined to the point of commencement aforesaid.

“(3) *West Ward.*

“Commencing at a point in the centre of Portland Road at the intersection of St. Leonard's Road thence Southward along the centre of St. Leonard's Road to the Foreshore thence Westward along the Foreshore to the Borough Boundary thence Northward following the line of the Borough Boundary to the Royal Military Canal and thence Eastward along the Southern Boundary of the North Ward to the point of commencement aforesaid.

“(4) *South Ward.*

“Commencing at a point in the centre of Portland Road at the intersection of St. Leonard's Road thence Eastward along the Southern Boundaries of the North and East Wards to the Borough Boundary at Seabrook thence Southward following the line of the Borough Boundary thence Westward along the Foreshore to a point in the Foreshore opposite the centre of St. Leonard's Road thence Northward along the Eastern Boundary of the West Ward to the point of commencement aforesaid.

“The boundaries as described are more particularly delineated in the Plan which is annexed hereto and forms part of the Scheme.

And whereas the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 5th day of March, 1925, in the words and figures following, that is to say :—

“ We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Anne, situate at Thwaites, in the Parish of Millom, in the County of Cumberland and in the Diocese of Carlisle :

“ Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Anne, situate at Thwaites as aforesaid :

“ Now, therefore, with the consent of the Right Reverend Henry Herbert, Bishop of Carlisle, (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said Parish of Millom which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Anne, situate at Thwaites as aforesaid, and that the same should be named ‘ The District Chapelry of Thwaites ’.

“ And with the like consent of the said Henry Herbert, Bishop of Carlisle, (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings and burials should be solemnized or performed at the said Church of Saint Anne, situate at Thwaites as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the minister of the same church for the time being.

“ We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to

make such Order with respect thereto as to Your Majesty, in Your Royal Wisdom, shall seem meet.

“ The SCHEDULE to which the foregoing Representation has reference.

“ The District Chapelry of Thwaites being :—

“ All that part of the Parish of Millom, in the County of Cumberland and in the Diocese of Carlisle, which is bounded upon the east partly by the Extra Parochial Place called or known as Angerton Moss and partly by the Chapelry of Broughton, both in the County of Lancaster and in the said Diocese of Carlisle, upon the north by the Chapelry of Ulpha, upon the west partly by the Parish of Corney, partly by the Parish of Bootle and partly by the Parish of Whicham, all in the said County of Cumberland and in the said Diocese of Carlisle, and upon the remaining side, that is to say, upon the south by an imaginary line commencing upon the boundary which divides the said Parish of Whicham from the said Parish of Millom at the point where such boundary meets the middle of the stream known as Bleamoss Pool, and extending thence first north eastward and then in various directions along the middle of the said stream for a distance of 44 chains or thereabouts to the centre of the culvert which carries the road leading from Whicham to The Green across such stream, and extending thence eastward in a straight line for a distance of 41 chains or thereabouts to the junction of Woodhouse Lane with Millom Road, and extending thence south eastward in a straight line for a distance of 50½ chains or thereabouts to the centre of the level crossing on the line of the Furness Railway south of Greenroad Station which is known as Occupation Crossing, and continuing thence south eastward in precisely the same direction and in a straight line for a distance of 1 mile and 13 chains or thereabouts to a point in the middle of the River Duddon upon the boundary which divides the said Parish of Millom from the said Extra Parochial Place called or known as Angerton Moss.”

And whereas the said Representation has been approved at the Council held under the authority of the said Commission :

of Winchester, and Henry Auriol Barker are therefore the Patrons or persons entitled to present or nominate to the said Benefice in case the same were now vacant:

"And whereas the said Frank Theodore, Bishop of Winchester, and Henry Auriol Barker are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint John, Newhall, now vested in them as aforesaid, should be transferred to and be vested in the Bishop of Southwell for the time being:

"And whereas the Right Reverend Edwyn, now Bishop of Southwell, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary he, the said Edwyn, Bishop of Southwell, has executed this Scheme as hereinafter mentioned:

"And whereas the transfer of the Patronage of the said Benefice of Saint John, Newhall, which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the New Parish of Saint John, Newhall:

"Now, therefore, with the consents of the said Frank Theodore, Bishop of Winchester, and Henry Auriol Barker, being the persons whose consents as Patrons are required by the provisions of the hereinbefore mentioned Acts and of the Act of the 1st and 2nd years of Her said late Majesty, Chapter 106 (in testimony of which consents they have signed and sealed this Scheme), and with the consent of the said Edwyn, Bishop of Southwell (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint John, Newhall, now vested in them, the said Frank Theodore, Bishop of Winchester, and Henry Auriol Barker, as aforesaid, shall be transferred to the said Edwyn, Bishop of Southwell, and his successors in the same Bishopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Edwyn, Bishop of Southwell, and by his successors in the same Bishopric for ever.

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Act, 1919, and of the Union of Benefices Measure, 1921, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the union of two neighbouring Benefices that is to say, the Benefice (being a Rectory) of Morton on the Hill and the Benefice (being a Vicarage) of Ringland, both of which Benefices are situate in the County of Norfolk and in the Diocese of Norwich:

"Whereas Commissioners appointed at our request by the Right Reverend Bertram, Bishop of Norwich, pursuant to the provisions of the said Union of Benefices Act, 1919, to inquire into and report upon the union of the said two Benefices of Morton on the Hill and Ringland duly made their report to the said Bishop of Norwich and therein recommended the union of the said two Benefices and the terms for effecting the union, and the said Bishop of Norwich signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the said Report:

"And whereas the said Benefice of Ringland is now full, the Reverend Robert Raven Young being the present Incumbent thereof and the said Benefice of Morton on the Hill is now vacant:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Bertram, Bishop of Norwich, (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. That the said Benefice of Morton on the Hill and the said Benefice of Ringland shall be permanently united together and form one Benefice with cure of souls under the style of 'The United Benefice of Ringland with Morton' but the Parishes of the said Benefices shall continue distinct in all respects.

"2. That if upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette both of the said two Benefices shall be vacant, the union of the same two Benefices shall take effect forthwith; and if the said Benefice of Morton on the Hill only shall be then vacant the said union shall also take effect forthwith if the Incumbent of the other of the said two Benefices shall consent to become the first Incumbent of the United Benefice, but if he shall not so consent, then the said union shall take effect upon the then next avoidance of the said Benefice of Ringland and the then Incumbent of Morton on the Hill shall be the first Incumbent of the United Benefice; and if the said Benefice of Ringland only shall be then vacant the said union shall take effect upon the next avoidance of the said Benefice of Morton on the Hill and if neither of the said two Benefices be then vacant, then the said union shall take effect on the next avoidance of the said Benefice of Morton on the Hill if the Incumbent

at that time of the said Benefice of Ringland shall have been instituted to Ringland subsequently to the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or if instituted before that date shall consent to become the Incumbent of the United Benefice; but if he shall have been instituted to Ringland before that date and shall not so consent, then the said union shall take effect immediately upon the next vacancy of the Benefice of Ringland following such avoidance of the Benefice of Morton on the Hill and the then Incumbent of Morton on the Hill shall become the first Incumbent of the United Benefice.

" 3. That upon the said union taking effect the parsonage House at present belonging to the said Benefice of Ringland shall become and be the house of residence for the Incumbent of the United Benefice.

" 4. That after the said union has taken effect the course and succession in which the respective Patrons shall present or nominate to the United Benefice from time to time as the same shall become vacant shall be as follows, that is to say, the right of presentation shall be exercised by the Patrons of the said two Benefices alternately, the Patron of the said Benefice of Morton on the Hill having the right upon the first presentation to the United Benefice to be made after the union and every alternate right of presentation and the Patron of the said Benefice of Ringland having the right of presentation upon the second presentation to the United Benefice to be made after the union and every alternate turn thereafter.

" Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or Measure, or of any other Act of Parliament, or Measure of the National Assembly of the Church of England."

And whereas drafts of the said Scheme have been published locally in the manner prescribed in the Statutory Rules made under the said Act and also transmitted in the manner so prescribed to the Patrons affected, together with a Notice in each case requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the same Rules:

And whereas certain objections have been so stated or transmitted to the said Ecclesiastical Commissioners within the time prescribed in the same Rules:

And whereas the said Ecclesiastical Commissioners after giving full consideration to such objections have deemed right to make no alterations in such draft Scheme:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Norwich has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas no appeal has been made to His Majesty in Council within the period of one month after the date of the said public notice in accordance with the provisions of the said Act against the said Scheme or any

part thereof by any person who has made objection as aforesaid to the said Draft Scheme:

And whereas neither of the two Benefices affected by the said Scheme is situate in a City or Municipal Borough:

And whereas the said Scheme has been approved on behalf of His Majesty at the Council held under the authority of the said Commission:

Now, therefore, His Royal Highness The Prince Henry, His Grace the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and the Prime Minister and First Lord of the Treasury, being authorised thereto by His Majesty's said Commission, have taken the said Scheme into consideration, and do hereby, by and with the advice of His Majesty's Privy Council, on His Majesty's behalf, affirm the said Scheme and order, as it is hereby ordered, that the two Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act.

And do, by and with the like advice, hereby direct that this Order be forthwith registered by the Registrar of the said Diocese of Norwich.

and 20th years of Her said late Majesty, Chapter 104, and of the Act of the 35th and 36th years of Her said late Majesty, Chapter 14, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 5th day of March, 1925, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, and of the Act of the 35th and 36th years of Her said late Majesty, Chapter 14, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the New Parish (sometime District Chapelry) of Saint John the Baptist, Irlam, partly out of the Parish of Flixton, both in the County of Lancaster and in the Diocese of Manchester, partly out of the New Parish (sometime District Chapelry) of Saint Mary, Partington, and partly out of the New Parish (sometime District Chapelry) of Saint George, Carrington, both in the County of Chester and in the Diocese of Chester:

“ Whereas we are satisfied that the said New Parish of Saint John the Baptist, Irlam, the said Parish of Flixton, the said New Parish of Saint Mary, Partington, and the said New Parish of Saint George, Carrington, are Cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said New Parish of Saint John the Baptist, Irlam, of the said Parish of Flixton, of the said New Parish of Saint Mary, Partington, and of the said New Parish of Saint George, Carrington, which are hereinafter mentioned and described, should be constituted a separate District in the manner which is hereinafter set forth:

“ And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

“ And whereas a piece of land situate within the said proposed separate District has been conveyed to us, the said Ecclesiastical Commissioners, as the site for a permanent Church

for such District, and there has been contributed and paid to the credit of our account at the Bank of England a capital sum of £2,000 towards the cost of erecting such permanent Church:

“ And whereas the said capital sum of £2,000 has been contributed and paid as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of Patronage of the said proposed District, and when such District shall have become a New Parish, then of the said New Parish, and the nomination of the Minister or Incumbent thereof should be assigned in the manner which is hereinafter set forth:

“ And whereas the contributors of the said capital sum of £2,000 towards the cost of erecting such permanent Church have nominated to us the Bishop for the time being of the said Diocese of Manchester, as the person to whom they desire that the whole right of Patronage of the said proposed District or New Parish should be assigned:

“ Now, therefore, with the consent of the Right Reverend William, now Bishop of Manchester, and with the consent of the Right Reverend Henry Luke, Bishop of the said Diocese of Chester (in testimony whereof they have signed this Scheme and sealed the same with their respective Episcopal Seals), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said New Parish of Saint John the Baptist, Irlam, of the said Parish of Flixton, of the said New Parish of Saint Mary, Partington, and of the said New Parish of Saint George, Carrington, which are described in the Schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the Map or Plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid become and be constituted a separate District for spiritual purposes, and that the same shall be named ‘The District of Saint Mary, Cadishead,’ and that such District shall be included in and shall form part of the Rural Deanery of Eccles, of the Archdeaconry of Manchester, and of the said Diocese of Manchester.

“ And we further recommend and propose that the whole right of Patronage of the said District so recommended to be constituted and, when such District shall have become a New Parish as aforesaid, then of the said New Parish, and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in the said William, Bishop of the said Diocese of Manchester, and his successors for ever.

“ And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

" THE SCHEDULE to which the foregoing Scheme has reference.

" The District of Saint Mary, Cadishead, comprising:—

" All those contiguous portions of the New Parish (sometime District Chapelry) of Saint John the Baptist, Irlam, of the Parish of Flixton, both in the County of Lancaster and in the Diocese of Manchester, of the New Parish (sometime District Chapelry) of Saint Mary, Partington, and of the new Parish (sometime District Chapelry) of Saint George, Carrington, both in the County of Chester and in the Diocese of Chester, which, taken together, are bounded upon the north partly by the New Parish of Astley, in the said County of Lancaster and in the said Diocese of Manchester, and partly by the New Parish of All Saints, Glazebury, in the said County of Lancaster and in the Diocese of Liverpool, upon the south west partly by the Parish of Newchurch and partly by the New Parish of Hollinfare, both in the said County of Lancaster and in the said Diocese of Liverpool, and upon the remaining sides, that is to say, upon the south east and upon the north east by an imaginary line commencing at the point in the Manchester Ship Canal where the boundaries of the said New Parish of Hollinfare, the said New Parish of Saint Mary, Partington, and the said New Parish of Saint John the Baptist, Irlam, all meet, and extending thence north eastward along the boundary which divides the said New Parish of Saint Mary, Partington, from the said New Parish of Saint John the Baptist, Irlam, for a distance of 4 chains or thereabouts to the point where it crosses the middle of the Manchester Ship Canal, and extending thence north eastward along the middle of the Manchester Ship Canal (thereby crossing the boundaries which divide the said New Parish of Saint Mary, Partington, from the said New Parish of Saint John the Baptist, Irlam; the said New Parish of Saint George, Carrington, from the said New Parish of Saint John the Baptist, Irlam; the said Parish of Flixton from the said New Parish of Saint John the Baptist, Irlam; and the said New Parish of Saint George, Carrington, from the said Parish of Flixton) for a distance of 2½ miles or thereabouts to the centre of the bridge which carries the Manchester and Liverpool Line of the Cheshire Lines Railway across the said canal, and extending thence south westward along the middle of the said line of railway for a distance of 1 mile and 5 chains or thereabouts to a point opposite to the middle of the tramway of the Manchester Corporation Cleansing Department, and extending thence north westward to and along the middle of the said tramway for a distance of 2½ miles or thereabouts to the boundary which divides the said New Parish of Saint John the Baptist, Irlam, from the said New Parish of Astley."

Now, therefore, His Royal Highness The Prince Henry, His Grace the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and the Prime Minister and First Lord of the Treasury, being authorized thereto by His Majesty's said Commission, do hereby, by and with the advice of His Majesty's Privy Council, on His Majesty's behalf, ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And do further by and with the like advice, direct that this Order be forthwith registered by the Registrar of the said Diocese of Manchester and by the Registrar of the said Diocese of Chester.

ing Scheme for effecting the union of two neighbouring Benefices, that is to say the Benefice (being a Vicarage) of Bourton and the Benefice (being a Rectory) of Silton, both of which Benefices are situate in the County of Dorset and in the Diocese of Salisbury:

"Whereas Commissioners appointed at our request by the Right Reverend St. Clair George Alfred, Bishop of Salisbury, pursuant to the provisions of the said Union of Benefices Act, 1919, to inquire into and report upon the union of the said two Benefices of Bourton and Silton duly made their Report to the said Bishop of Salisbury and therein recommended the union of the said two Benefices and the terms for effecting the union, and the said Bishop of Salisbury signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the said Report:

"And whereas the said Benefice of Bourton is now full, the Reverend James Ralph Scholfield being the present Incumbent thereof and the said Benefice of Silton is at present vacant:

"And whereas the said James Ralph Scholfield has consented to become the first Incumbent of the United Benefice, if and when the union which is hereinafter recommended and proposed shall take effect:

"And whereas as soon as conveniently may be after the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme the Patron of the said Benefice of Silton and the Patrons of the said Benefice of Bourton intend with the approval of the Bishop of Salisbury to enter into an agreement with a view to making provision for the exercise of the Patronage of the United Benefice hereinafter recommended and proposed to be constituted:

"And whereas there is charged upon the revenues of the said Benefice of Silton a pension in excess of £100 per annum to the Reverend Ashley Lawrence Barnes-Lawrence, late Incumbent of such Benefice:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said St. Clair George Alfred, Bishop of Salisbury (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. That the said Benefice of Bourton and the said Benefice of Silton shall be permanently united together and form one Benefice with cure of souls under the style of 'The United Benefice of Bourton with Silton' but the Parishes of the said Benefices shall continue distinct in all respects.

"2. That upon the day when any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette the union shall forthwith take effect and the said James Ralph Scholfield if he is then Incumbent of the said Benefice of Bourton shall be the first Incumbent of the United Benefice.

"3. That upon the said union taking effect the Parsonage House at present belonging to the said Benefice of Bourton shall become and be the house of residence for the Incumbent of the United Benefice and so soon as conveniently may be the Parsonage House at

present belonging to the said Benefice of Silton and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall be sold and disposed of by us the said Ecclesiastical Commissioners at such time or times and in such manner in all respects as to us shall seem expedient and that the net proceeds of such sale shall constitute and form part of the Expenses Fund established pursuant to the 32nd Section of the said Union of Benefices Measure, 1923.

"4. That after the said union has taken effect and until an agreement as to the Patronage of the United Benefice has been entered into as hereinbefore mentioned the course and succession in which the respective Patrons shall present or nominate to the United Benefice from time to time as the same shall become vacant shall be as follows, that is to say, the right of presentation shall be exercised by the Patrons of the said two Benefices alternately, the Patron of the said Benefice of Silton having the right upon the first presentation to the United Benefice to be made after the union and every alternate right of presentation and the Patrons of the said Benefice of Bourton having the right of presentation upon the second presentation to the United Benefice to be made after the union and every alternate turn thereafter.

"5. That upon the said union taking effect or upon the cessation of the said pension payable to the said Ashley Lawrence Barnes-Lawrence if such pension has not ceased before the union takes effect, all the Tithe Rent Charges, Glebe Lands, and all (if any) other the Endowments belonging to the said United Benefice or which may hereafter belong thereto shall be charged and for ever after be chargeable in favour of the Incumbent for the time being of the Benefice of Salisbury, Saint Edmund, situate in the said Diocese of Salisbury, with the annual sum or yearly rent charge hereinafter mentioned, that is to say, a clear annual sum or yearly rent charge equivalent in amount to the gross yearly value of a sum of £91 11s. 7d. Tithe Rent Charge as determined in accordance with the Statutory provisions for the time being and from time to time in force for ascertaining the sum payable in respect of Tithe Rent Charge and to be paid half yearly as hereinafter provided and so that the amount of the half yearly instalment of the said yearly rent charge to be paid on each half yearly day hereunder shall be the same or the like amount as would in accordance with the aforesaid Statutory provisions have become payable in respect of such sum of £91 11s. 7d. Tithe Rent Charge on the last preceding half yearly day for payment of Tithe Rent Charge the said yearly rent charge to be as from the date of the union taking effect or as from the date of the cessation of the said pension as the case may be. due and payable to the Incumbent of the said Benefice of Salisbury Saint Edmund, and to be apportionable between any outgoing Incumbent of the said Benefice of Salisbury, Saint Edmund, or his representatives on the one hand and his successor in the same incumbency on the other hand, and to be receivable by the Incumbent in whose favour it is charged as aforesaid by half yearly instalments on the first day of January and the first day of July in every year. And for the recovery of the said yearly rent charge the In-

cumbent of the said Benefice of Salisbury, Saint Edmund, and his successors shall have and be entitled to all such or the like powers and remedies as are expressed to be conferred by Section 44 of the Conveyancing and Law of Property Act, 1881, in relation to rent charges within the purview of that Section.

“ Provided always that if at any time by reason of any redemption of Tithe Rent Charge belonging to the said United Benefice or any sale of or other transfer of the right to receive any such Tithe Rent Charge the endowments chargeable with the said yearly rent charge shall no longer include any sum whatsoever of Tithe Rent Charge then and in such case as from the date on which such redemption sale or transfer shall take effect the amount of the said yearly rent charge shall cease to be regulated by the value of Tithe Rent Charge and shall thereafter be a fixed annual sum equivalent to the amount payable in respect of the said yearly rent charge for the year ending on the half yearly day for the payment thereof which last preceded the aforesaid date. Provided also that if at any time the Incumbent for the time being of the said United Benefice shall by any deed duly executed by him under his hand and seal in accordance with the provisions of any Statute in that behalf enabling him grant convey and annex or if by any other instrument in accordance with statutory authority there shall at any time be annexed to the said Benefice of Salisbury, Saint Edmund, in lieu of or in substitution for the yearly rent charge hereby created any part or parts of the endowments belonging to the said United Benefice which shall in the opinion of the Bishop of Salisbury for the time being be a just and fair equivalent or not less than an equivalent for the yearly rent charge hereby created as aforesaid then the said yearly rent charge shall thereupon and thenceforth cease and be no longer payable.

“ And provided further that the whole of the First Fruits and Tenths now or hereafter payable to the Governors of Queen Anne's Bounty in respect of the said United Benefice shall continue to be payable by the Incumbent of the said United Benefice.

“ Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or Measures, or of any other Act of Parliament, or Measure of the National Assembly of the Church of England.”

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and notices have been transmitted to the persons or bodies entitled under the same Measure to receive notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923 :

" Whereas Commissioners appointed at our request by the Right Reverend Bertram, Bishop of Norwich, pursuant to the provisions of the said Union of Benefices Act, 1919, to inquire into and report upon the union of the said Benefice of Wickhampton and a portion of the said Benefice of Reedham with Freethorpe duly made their Report to the said Bishop of Norwich and therein recommended the severance from the said Benefice of Reedham with Freethorpe of so much of such Benefice as comprises the ancient Benefice of Freethorpe and the union of the Benefice of Freethorpe so severed with the said Benefice of Wickhampton and the said Bishop of Norwich signified in writing his approval of the said Report:

" And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the said Report:

" And whereas both of the said Benefices of Wickhampton and Reedham with Freethorpe are now full, the Reverend Arthur Emms being the present Incumbent of the said Benefice of Wickhampton, and the Reverend Edward John Wolfe being the present Incumbent of the said Benefice of Reedham with Freethorpe:

" And whereas the revenues of the said Benefice of Reedham with Freethorpe are charged with a pension of one hundred and ninety six pounds, eleven shillings, payable to the Reverend William Maingay Selwyn, late Incumbent of such Benefice and the said William Maingay Selwyn has consented to the apportionment of the said pension in the manner hereinafter recommended and proposed:

" Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Bertram, Bishop of Norwich (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

" 1. That a portion of the said Benefice of Reedham with Freethorpe, that is to say the Benefice of Freethorpe, shall be severed from the said Benefice of Reedham with Freethorpe, and that the Benefice of Freethorpe, so severed, and the said Benefice of Wickhampton shall be permanently united together and form one Benefice with cure of souls under the style of 'the United Benefice of Freethorpe with Wickhampton' but the Parishes of the said Benefices of Freethorpe and Wickhampton shall continue distinct in all respects.

pounds, eight shillings and tenpence Local Loans Three pounds per centum per annum Stock being part of a larger sum of the same Stock held by us the said Ecclesiastical Commissioners on behalf of the said Benefice of Reedham with Freethorpe, provided that the whole of the First Fruits and Tenths now or hereafter payable to the Governors of Queen Anne's Bounty in respect of the said Benefice of Reedham with Freethorpe shall continue to be payable by the Incumbent of the said Benefice of Reedham. And provided also that upon the union taking effect the pension payable to the said William Maingay Selwyn as aforesaid shall be apportioned as follows that is to say a sum of Thirty seven pounds three shillings and eightpence shall be payable by the Incumbent of the United Benefice of Freethorpe with Wickhampton and a sum of One hundred and fifty nine pounds seven shillings and fourpence shall be payable by the Incumbent of the said Benefice of Reedham.
