The following Statute made by the University of Oxford Commissioners, and sealed on the 18th day of April, 1925, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

### APPROVAL OF NOMINATIONS OF EXAMINERS.

STATUTE.

REGISTRAR.

Whereas it is expedient to provide that the names of Moderators and Public Examiners may be approved at a single meeting of Congregation after due notice shall have been given, THE UNIVERSITY ENACTS AS FOLLOWS.

1. In Statt. Tit. VI. Sect. 1 E. § 7. cl. 1 (Examination Statutes, ed. 1924, p. 171), the word "Convocation" shall be struck out and the word "Congregation" shall be substituted.

2. Ibid., § 7, cl. 2 shall be struck out and the following new clause shall be substituted:—

"2. The names of Moderators and Public Examiners shall, after not less than ten days' notice of their nomination has been given, be submitted to the vote of Congregation in the course of the Term in which the nominations have been made."

3. Ibid., in § 8 (p. 171) and in § 10, cl. 4, the word "Convocation" shall be struck out and the word "Congregation" shall be substituted.

WE, the University of Oxford Commissioners, under and by virtue of all and every the powers in this behalf enabling us contained in the Universities of Oxford and Cambridge Act, 1923, have, at a Meeting at which more than three members were present, made a Statute hereunto annexed for the University being a Statute made in accordance with the provisions of Section 31 of the Universities of Oxford and Cambridge Act, 1877, as set forth in the Schedule to the Universities of Oxford and Cambridge Act, 1923, and being a Statute wholly for the University.

Given under our Common Seal this eighteenth day of April, in the year of our Lord one thousand nine hundred and twenty-five.
