

APPOINTMENT OF STANDINGS FOR
SIX HACKNEY CARRIAGES.

By virtue of the Act 13 and 14 Victoria, chapter 7, intituled "An Act for consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of the Commissioners of Police of the Metropolis, and making other provisions in regard to the Consolidated Offices."

I, JAMES WILLIAM OLIVE, Acting Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for six Hackney Carriages at Oxford Street, W., in two portions, and do make the following Regulations with regard to the Boundaries for the same, viz. :—

First Portion.—Three carriages in centre of roadway, commencing six yards East of the refuge at junction with Dean Street, extending Eastward as far as necessary for three carriages.

Front of vehicles toward the West.

Second Portion.—Three carriages in centre of roadway, commencing three yards East of Eastern building line of Perry's Place, extending Eastward as far as necessary for three carriages.

Front of vehicles toward the West.

The first portion of the Standing to be fed exclusively by carriages from the second portion.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriageway, or upon any place where foot passengers usually cross the carriageway.
