SCHEDULE I.

Droxford Rural District.

Road from the Waterlooville-Hambledon-Droxford Road (B. 2150) at Forest Gate, via Rushmere to its junction with Hambledon Street at the George Hotel.

Road from the Shedfield-Botley Road (A. 334) on the West side of Shedfield House, via Grange Farm to the Curdridge-Waltham Chase Road, 400 yards West of the Bishops Waltham-Wickham Road (A. 333) with branch road to the Bishops Waltham-Wickham Road (A. 333) at 450 yards South of Waltham Chase Cross Roads.

Road from the Droxford-Kilmeston Road at Shepherd's Down, via Upper Swanmore to the Bishops Waltham-Droxford Road, about 350 yards North-west of Swanmore Church, with branch road from Upper Swanmore to the Bishops Waltham-Droxford Road about 200 yards South-east of Swanmore Church.

Road from the Droxford-Kilmeston Road at Shepherd's Down, via Dundry, to the Bishops Waltham-Corhampton Road (B. 3035) about $\frac{1}{2}$ mile North-east of Bishops Waltham.

Road from the South end of Durley Villiage, via Hill Farm, to the Botley-Bishops Waltham Road (B. 3035), 800 yards North-east of Botley Station, with branch roads joining B. 3035 at 220 yards and 900 yards respectively North-east of Botley Station.

Road from the Fishers Pond-Botley Road (A. 3051), 200 yards South-east of "The Croft," via Durley and Durley Manor Farm, to the Cross Roads at Durley Street, with branch road from Durley Manor Farm, via Mincingfield Farm, to the Road junction $\frac{1}{2}$ mile East of Durley Village.

Road from the Winchester-Bishops Waltham Road (A. 333) at the Alma Inn, Lower Upham, via Job's Corner, Snakemoor, and Stapleford Farm, to the Road junction at the South-west end of Durley Village, with branch road from Job's Corner to the Durley Street-Lower Upham Road 350 yards North-west of Durley Street, and branch road at Snakemoor to the Rural District Boundary towards Horton Heath.

Road from the Winchester-Bishops Waltham Road (A. 333), 1 mile North-west of Bishops Waltham, via Ashton and Chapel Farm, to its junction with the Morestead-Bishops Waltham Road at Street End.

Road from the Winchester-Bishops Waltham Road (A. 333), near Wool-street Farm (both branch Roads), via Stake's Farm, Upham, and Bigpath to the Morestead-Bishops Waltham Road at Stephens Castle Down.

Road from the Bishops Waltham-Corhampton Road (B. 3035), 1 mile West of Corhampton, via Beacon Hill to the Winchester-Cheesefoot Head-Preshaw-Warnford Road, $1\frac{1}{2}$ miles West of Warnford.

Road from Wickham-West Meon Road (A.32) at Warnford (both branch Roads) to the Bramdean-West Meon Road, 300 yards North of Lippen Cottages.

SCHEDULE II.

Droxford Rural District.

Road from the Wickham-Droxford-West Meon Road (A. 32), 200 yards South of Corhampton, via Meonstoke, to the Droxford-Hambledon Road (B. 2150) at Brockbridge.

Road from the Morestead-Bishops Waltham Road, 100 yards South-east of the entrance to Belmore House, to the Bishops Waltham-Corhampton Road (B. 3035), one mile West of Corhampton.

Road from the Wickham-West Meon Road (A. 32) at Warnford, via Wheeley Down, towards Winchester to the Rural District Boundary, 450 yards East of the Fox and Hounds Public House, Beauforth.

Road from the Sheffield-Botley Road (A. 334) at Curdridge to the Botley-Swanwick Road (A. 27) at the entrance to Fairthorn Grange.

Road from the Winchester Bishops Waltham Road (A. 333), 200 yards South-east of the Alma Inn, Lower Upham, via Wintershill House, to the Durley-Bishops Waltham Road at Durley Street.

SCHEDULE III.

City of Winchester.

Kingsgate Street, Winchester (including St. Swithun's Archway) from junction with St. Swithun's Street to the junction with Roman's Road.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 9TH JUNE, 1925.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Application of Part I of Sheep (Double Dipping) Order of 1920.

1.—(1) Part I. (*Restriction of Movement of Sheep out of a Movement Area*) of the Sheep (Double Dipping) Order of 1920, hereinafter referred to as "The Principal Order," is hereby applied to the area described in the First Schedule hereto, which shall be a Movement Area for the purposes of that Order.
