(b) Cottage, 3s. per week (less any rent or rates which may be paid by the occupier), provided as follows :—

In the case of a cottage with regard to which the Committee on an application by or on behalf of a worker have certified that by reason of inadequate accommodation, want of repair or sanitation or lack of water supply the value of such cottage is less than 3s., the value shall be such sum less than 3s. as the Committee shall

determine on a consideration of the defects, less any rent or rates paid by the occupier.

3. In pursuance of their said powers the said Committee hereby order that except as in this Order provided no benefit or advantage shall be reckoned as payment of wages in lieu of cash.

4. This Order shall come into operation on 28th June, 1925.
