

ORDER OF THE REGISTRAR GENERAL
IN ENGLAND.*(Dated 18th June, 1925.)*

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Southwark Registration of Births, &c. (Alteration of Sub-districts) Order, 1925, and shall come into operation on the 1st day of July, 1925.

2. The existing Newington North Sub-district of Southwark Registration District shall be extended by the addition of Newington South Sub-district of the same Registration District and the extended Sub-district shall be known by the name of the Newington Sub-district.

3. The Registrar of the existing Newington North Sub-district shall be the Registrar of the Newington Sub-district constituted by this Order.

NORTH SOMERSET ELECTRICITY (EXTENSION)
SPECIAL ORDER, 1925.

NOTICE is hereby given that the Electricity Commissioners have submitted to the Minister of Transport for confirmation under the above-mentioned Acts a Special Order made by them for the supply by the North Somerset Electric Supply Company Limited of electricity within the City of Wells, the Borough of Glastonbury, the Urban Districts of Highbridge Midsomer Norton Radstock and Shepton Mallet part of the Urban District of Burnham the Rural District of Clutton and parts of the Rural Districts of Axbridge Bath Frome Keynsham Shepton Mallet and Wells all in the County of Somerset.

The Minister of Transport proposes to confirm the Order and gives notice that any person affected who may be desirous of objecting to the confirmation of the same must in accordance with the Electricity (Confirmation of Special Orders) Rules, 1921, do so by memorial addressed to the Minister of Transport written on one side only of foolscap paper and sent by registered post addressed to The Secretary, Ministry of Transport, 6, Whitehall Gardens, London, S.W. 1, and posted not later than the 17th day of July, 1925. A copy of any such memorial must also be sent in like manner to Messrs. Lees and Company, Palace Chambers, Bridge Street, Westminster, London, S.W. 1, Parliamentary Agents for the Order. Such memorial must be sealed or signed by the person objecting or by some responsible and duly authorised person on his behalf and must state the specific grounds of objection to the Order and the modifications desired.
