

Parish of Elvaston :—
Borrowash Bridge over the river Derwent.

Parish of Kirk Hallam :—
Bridge carrying the road from Kirk Hallam to Ilkeston over the London Midland and Scottish Railway (Stanton and Shipley).

Bridge carrying the road from Kirk Hallam to Ilkeston over the Nutbrook Canal.

Parish of Ockbrook :—
Bridge carrying Station Road over the London Midland and Scottish Railway (Derby and Nottingham).

Bridge carrying Station Road over the Derby Canal.

— Borrowash Bridge over the river Derwent.

Parish of Shardlow and Great Wilne :—
Bridges carrying the Derby-Loughborough road and Wilne Road over the Trent and Mersey Canal.

Parish of Stanley :—
Bridges carrying Morley Lane and the road from Stanley to Stanley Common over the London and North Eastern Railway (Derbyshire and Staffordshire Line).

Parish of Stanton-by-Dale :—
Bridge carrying the road from Stanton Gate to New Stapleford over the London Midland and Scottish Railway.

Bridge carrying the road from New Stanton to Ilkeston over the London Midland and Scottish Railway (Stanton and Shipley).

Bridge carrying the road from Stanton Gate to New Stapleford over the Erewash Canal.

Stanton Bridge and bridge carrying the road from Stanton Gate to Hallam Fields over the Nutbrook Canal.

Bridge carrying Low's Lane over mineral railway.

Parish of Swarkeston :—
Bridge carrying the road from Swarkeston to Chellaston over the London Midland and Scottish Railway (Derby and Melbourne).

Bridges carrying the road from Swarkeston to Chellaston and the road from Swarkeston to The Lowes over the London Midland and Scottish Railway (Stenson and Weston).

Cuttle Bridge and Lowes Bridge over the Trent and Mersey Canal.

Parish of West Hallam :—
Bridge carrying the road from Foxhole Farm to West Hallam over the London and North Eastern Railway (Derbyshire and Staffordshire Line).

Parish of Weston-upon-Trent :—
Bridges carrying the road from Weston-upon-Trent to Swarkeston and the roads from Weston-upon-Trent to Kings Mills Ferry over the London Midland and Scottish Railway (Sawley and Weston).

Bridges carrying the road from Weston-upon-Trent to Kings Mills Ferry and the road at Weston Grange over the Trent and Mersey Canal.

(D) Roadways under the following bridges :—

Parish of Weston-upon-Trent :—
Bridge carrying the London Midland and Scottish Railway (Derby and Melbourne) over the road from Weston-upon-Trent to Swarkeston.

Parish of West Hallam :—
Bridges carrying the London and North Eastern Railway (Derbyshire and Staffordshire Line) over the Ilkeston-Derby Road and the road from West Hallam to Stanley.

(E) Railways :—

Parish of Breaston :—
Level crossing of the London Midland and Scottish Railway (Derby and Nottingham) at Sawley Station.

Parish of Stanton-by-Dale :—
Level crossing of mineral railway in the road from New Stanton to Stanton-by-Dale near New Stanton.

Level crossing of the London Midland and Scottish Railway (Stanton Old Ironworks Branch) at Low's Lane.

Level crossing of Mineral railways entering Stanton Ironworks at Low's Lane.

5. The streets and parts of streets in which it is proposed that electric lines shall be laid down within a period to be specified by the Order are as follows :—

In the rural district of Shardlow :—

Parish of Breaston :—
Draycott Road for 300 yards west from Stevens Lane, Main Street from Bull's Head Inn to Stevens Lane.

Parish of Draycott and Church Wilne :—
Derby Road from Lime Grove to Hopwell Road, Victoria Road.

Parish of Ockbrook :—
Derby Road, Nottingham Road from Station Road to Brook Road, Station Road, Victoria Avenue from Derby Road to Bakehouse Lane.

Parish of Shardlow and Great Wilne :—
The Derby-Loughborough road from the Union Workhouse to Wilne Road.
