Read from the Shaftesbury-Sutton Waldron-Blandford road near the Police Station, West Melbury, via House's Farm to its junction with the Shaftesbury-Melbury Abbas-Blandford road near Parham's Farm, Melbury Abbas, including the branch from a point about 200 yards north-east of the said Police Station to the Shaftesbury-Melbury Abbas-Blandford road near St. Thomas's Church, Melbury Abbas.

Rural District of Sturminster.

Waterloo Lane and Cat Lane from the Stalbridge-Lydlinch road near Warr Bridge to the road junction about 150 yards south of Barrow Hill Farm, Stourton Caundle.

Rural District of Wareham and Purbeck.

Road from West Lane, Stoborough, via Stoborough Heath and Holme Lane Plantation to its junction with the East Lulworth-West Holme road at West Holme.

Road from the East Lulworth-West Holme road at West Holme via Stoke Common, Puddle Coppice and Bindon Abbey to its junction with the West Lulworth-Coombe Keynes-Wool road near the Vicarage, Wool.

Road from Barnston Cross Roads near Church Knowle via Puddle Mill Farm and south of Bradle Farm to the road junction near the Church, Kimmeridge.

Road from the East Lulworth-West Lulworth road near Monastery Lane via the Tumuli, Whiteway Hill and Lawford Sheard Gate to St. Mary's Church, Tyneham.

Road from the road junction at the King's Head Inn, Bradpole, via Holy Trinity Church and Metz House, Bradpole, and the School and Yondover Farm, Loders, to its junction with New Road at the Crown Inn, Uploders.

Acreman Street, Cerne Abbas, from the road junction about 150 yards south-east of the Workhouse to its junction with the Folly.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES. (DATED 1ST JULY, 1925.)

FOOT-AND-MOUTH DISEASE (AMEND-MENT) ORDER OF 1925 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Amendment of Article 3 of the Foot-and-Mouth Disease Order of 1895.

1. Article 3 of the Foot-and-Mouth Disease Order of 1895 (hereinafter referred to as the "Principal Order") as amended by the Footand-Mouth Disease (Amendment) Order of 1922 is hereby revoked, and the following substituted therefor:---

"Local Authority to consult Veterinary Inspector as to existence of Foot-and-Mouth Disease.

3.—(1) A Local Authority, in making an inquiry, under Sub-section (5) of Section 8 of the Act of 1894 into the correctness of an Inspector's declaration respecting the existence of foot-and-mouth disease in any place, shall obtain the assistance and advice of a Veterinary Inspector or of a person qualified according to the Act of 1894 to be such.

(2) Every such Veterinary Inspector or person shall, before entering any premises in which foot-and-mouth disease exists, or is suspected to exist, put on suitable overall clothing and boots which are disinfectable, and shall on leaving such premises thoroughly disinfect his hands, overall clothing and boots.

(3) The Local Authority shall supply to every such person the overall clothing and boots required to be used under the foregoing provision."

Commencement.

2. This Order shall come into operation on the fifteenth day of July, nineteen hundred and twenty-five.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (AMENDMENT) ORDER OF 1925 (No. 2).
