The Queen and I remember with pride and gratification the warm welcome extended to our eldest son in his visits to different parts of the Empire, and we realise that nowhere was that welcome more friendly than in Canada, whose people took him to their hearts from the moment that he set foot upon Canadian soil.

The Queen and I are very glad to take part in to-day's ceremony and to see the new home of Canada in London.

Canada is a great country: alike in the literal sense of vast extent from " sea to sea" and great in achievement and in promise: and it is right and necessary that its official representatives here should be housed in a manner worthy of the Dominion and adequate to the discharge of their ever-growing and important duties. I sincerely congratulate you upon the wise instinct which led to the choice of a site so well adapted to your needs and also upon the admirable reconstruction that has been effected.

I now have the pleasure of declaring the Canadian Building open. It is my earnest hope that it will in every way fulfil its purpose and that success may attend all who work within these walls.
