ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 16th July, 1925.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Bideford Registration of Births, &c. (Alteration of Sub-districts) Order, 1925, and shall come into operation on the 1st day of August, 1925.

2. The existing Bideford Sub-district of Bideford Registration District shall be extended by the addition of Northam Sub-district of the same Registration District and the extended Sub-district shall be known by the name of the Bideford Sub-district.

3. The Registrar of the existing Bideford Sub-district shall be the Registrar of that Sub-district as extended by this Order.

ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Blofield Registration of Births, &c. (Alteration of Sub-districts), Order, 1925, and shall come into operation on the 1st day of August, 1925.

2. The existing Blofield Sub-district of Blofield Registration District shall be extended by the addition of South Walsham Sub-district of the same Registration District, and the extended Sub-district shall be known by the name of the Blofield Sub-district.

3. The Registrar of the existing Blofield Sub-district shall be the Registrar of that Sub-district as extended by this Order.
