# ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 22nd July, 1925.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Manchester North Registration of Births &c. (Alteration of Sub-districts) Order, 1925, and shall come into operation on the 1st day of August, 1925.

2. The Failsworth Sub-district of Manchester North Registration District shall cease to exist and its constituent Wards shall be apportioned as follows:—

(a) The part of Blackley Ward of the City of Manchester shall be transferred to the Blackley Sub-district of Manchester North Boristration District.

North Registration District.
(b) The Moston Ward of the City of Manchester and the Higher Ward and Lower Ward of the Failsworth Urban District shall be transferred to the Newton Heath Sub-district of Manchester North Registration District.

3. The Miles Platting Ward of the City of Manchester, now situated in the Newton Heath Sub-district of Manchester North Registration District shall be transferred to the Bradford Sub-district of the same Registration District.

4. The Registrars of the existing Blackley, Newton Heath and Bradford Sub-districts shall, respectively, be the Registrars of those Sub-districts as altered by this Order.
