The KING's Most Excellent Majesty in Council.

WHEREAS by the Universities of Oxford and Cambridge Act, 1923, Commissioners are constituted styled the University of Oxford Commissioners:

And whereas it is further enacted in the Act aforesaid that "the powers of the Commissioners shall continue in force until the end of the year nineteen hundred and twenty-five and no longer: Provided that His Majesty in Council may, on the application of the Commissioners, continue their powers for such further period as His Majesty may think fit, but not beyond the end of the year nineteen hundred and twenty-seven":

And whereas the University of Oxford Commissioners have made application to His Majesty in Council for the continuation of their powers under the said Act until the end of the year nineteen hundred and twenty-six:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that the powers of the University of Oxford Commissioners shall continue until the end of the year nineteen hundred and twenty-six.

WHEREAS the Ecclesiastical Commissioners for England, have, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, and of the Act of the 29th and 30th years of Her said late Majesty, Chapter 86, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 18th day of June, 1925, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, and of the Act of the 29th and 30th years of Her said late Majesty, Chapter 86, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the New Parish (sometime Chapelry District) of Saint Clement, Spotland, partly out of the New Parish (sometime District Chapelry) of Saint Alban, Rochdale, and partly out of the New
