south westward, then north westward and then again south westward along the middle of such roadway for a distance of 7 chains or thereabouts to its junction with the road leading from Bury Road near Chadwick Hall past Broadhalgh towards Top o'th'Lane and Bagslate Moor, and extending thence first south westward, then westward and then north westward along the middle of the last mentioned roadway for a distance of 29 chains or thereabouts to its junction with the road leading from Bagslate Moor to the road connecting Broadhalgh and Bamford, and extending thence in a straight line due southwest for a distance of 1 chain or thereabouts to the boundary which divides the said New Parish of Saint Clement, Spotland, from the New Parish or Saint Michael, Bamford, in the said County and Diocese, and extending thence first south eastward and then in various directions along the last mentioned boundary (thereby crossing Bury Road) for a distance of 49 chains or thereabouts to the point in the middle of the River Roch where such boundary meets the boundary which divides the New Parish of Saint Aidan, Sudden, Rochdale, in the said County and Diocese, from the said New Parish of Saint Clement, Spotland, and extending thence first north eastward and then in various directions along the last mentioned boundary (thereby following the middle of the River Roch) for a distance of $1\frac{1}{2}$ miles or thereabouts to the point where such boundary meets the boundary which divides the said New Parish of Saint Aidan, Sudden, Rochdale, from the said New Parish of Saint Alban, Rochdale, at the centre of the bridge which carries the roadway leading from the Rochdale Corporation Sewage Farm to Corporation Road across the River Roch, ond extending thence north eastward and in a straight line for a distance of 10½ chains or thereabouts to a point in the middle of the south western end of Norman Road, and extending thence north eastward along the middle of Norman Road for a distance of 201 chains or thereabouts to its junction with Dane Street, and extending thence north eastward along the middle of Dane Street for a distance of 7 chains or thereabouts to its junction with Bridge Street, and extending thence north westward along the middle of Bridge Street for a distance of 2 chains or thereabouts to the centre of Bridge Street Bridge across the River Roch upon the boundary which divides the said New Parish of Saint Alban, Rochdale, from the said New Parish of Saint Clement, Spotland, and extending thence first northward and then eastward along the middle of the River Roch (thereby following in part the last mentioned boundary and in part the boundary which divides the said New Parish of Saint Alban, Rochdale, from the said New Parish of Falinge) for a distance of 17 chains or thereabouts to a point opposite to the middle of the southern end of Oliver Road, and extending thence north westward to and along the middle of Oliver Road for a distance of 5 chains or thereabouts to its junction with Bury Road, near the junction of the latter road with Mitchell Street, and extending thence first north eastward to and then first south westward, then north westward and then northward along the middle of Mitchell Street (thereby following in part the boundary which divides the said New Parish of Falinge

from the said New Parish of Saint Clement, Spotland), for a distance in all of 18½ chains or thereabouts to its junction with Spotland Road upon the last mentioned boundary, at which point the said imaginary line commenced."

And whereas drafts of the said Scheme have, in accordance with the provisions of the firstly hereinbefore mentioned Act, been transmitted to the Patrons and to the Incumbents of the Cures out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Manchester.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 18th day of June, 1925, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty. Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken out of the Parish of Monk Hesleden, in the County of Durham, and in the Diocese of Durham.

and in the Diocese of Durham:

"Whereas we are satisfied that the said
Parish of Monk Hesleden is a Parish wherein
or in parts whereof the provision for public
worship and for pastoral superintendence is
insufficient for the spiritual wants of the
inhabitants thereof and it has been made to
appear to us that it would promote the
interests of religion that the particular part of
the said Parish of Monk Hesleden which is
hereinafter mentioned and described should
be constituted a separate District in the
manner which is hereinafter set forth:
