pedient towards effecting the said proposed improvements at the Archiepiscopal Residence known as Lambeth Palace aforesaid.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in conformity with the provisions of the herein named Acts, or of either of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Canterbury.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 18th day of June, 1925, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 6th and 7th years of Her late Majesty Queen Victoria, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared and now humbly lay before Your Majesty in Council the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the Parish (sometime District under the firstly hereinbefore mentioned Act) of Saint Philip, Gorton, partly out of the Parish (sometime District under the firstly hereinbefore mentioned Act) of Saint Cyprian, Kirkmanshulme, partly out of the Parish (sometime District under the Parish of Manchester Division Act, 1850) of Saint Agnes, Birch, and partly out of the Parish (sometime District under the Parish of Manchester Division Act, 1850) of Saint Peter, Levenshulme, all within the original limits of the Parish of Manchester, in the County of Lancaster and in the Diocese of Manchester:

"Whereas we are satisfied that the said Parish of Saint Philip, Gorton, the said Parish of Saint Cyprian, Kirkmanshulme, the said Parish of Saint Agnes, Birch, and the said Parish of Saint Peter, Levenshulme, are Parishes wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof, and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said Parish of Saint Philip, Gorton, of the said Parish of Saint Cyprian, Kirkmanshulme, of the said Parish of Saint Agnes, Birch, and of the said Parish of Saint Peter, Levenshulme, which are hereinafter mentioned and described, should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed District any consecrated Church or Chapel in use for the

purposes of Divine Worship:

"And whereas we are satisfied that an adequate and permanent maintenance for the support of the Minister of the said proposed District, and when the said District shall have become a New Parish then for the support of the Incumbent thereof, will be secured as from the date of the licensing or appointment of such Minister or Incumbent by the payment of a sum of not less than £150, which will be annually provided out of the moneys received by us, the said Ecclesiastical Commissioners, under the provisions of the said Parish of Manchester Division Act, 1850:

"And whereas a Scheme for the application of a legacy of £10,000 bequeathed to the Community of the Resurrection at Mirfield, in the County of York, under the Will of the late Angelena Frances Clarke has been approved by an Order dated the 8th day of December, 1924, of the Chancery Division of Your Majesty's High Court of Justice in the Matter of the Estate of the said Angelena Frances Clarke deceased, whereby it was provided (interalia) that a portion not exceeding £2,400 of the Fund now representing the said legacy should be devoted to the purchase of a site, in the said Parish of Saint Philip, Gorton, suitable for the erection of a Church, Parsonage and Parish Room and to the payment of the costs of and incidental to such purchase; that the residue of the said Fund should be appropriated to the building of a permanent Church on the said site to be dedicated to 'Our Lady of Mercy and Saint Thomas of Canterbury and that the right of Patronage of and presentation to the Benefice of the said Church should be vested jointly in the Bishop of the Diocese, the Rector of the said Parish of Saint Philip, Gorton, the Superior for the time being of the Community of the Resurrection and two officers of the said Community to be nominated from time to time by the said Superior:

"And whereas the Reverend Edward Keble Talbot, the Superior of the Community of the Resurrection, has nominated to us, the said Ecclesiastical Commissioners, the Reverend John Hallward, Prior of the said Community, and the Reverend Frederick Horn King, Bursar of the said Community, as the persons to whom together with himself, the said Edward Keble Talbot, and the Right Reverend William, Bishop of the said Diocese of Manchester, and the Reverend Walter Scott Adams, Rector or Incumbent of the said Parish of Saint Philip, Gorton, the whole right of Patronage of the said proposed District or New Parish should be assigned:

"And whereas the said William, Bishop of Manchester, has signified his approval of the erection within the said proposed separate Dis-
