

linton and the said Henry Herbert, Bishop of Carlisle, it is hereinafter recommended and proposed that the said Advowson or perpetual right of Patronage should be transferred, that is to say, with the consents of the Venerable Herbert Ernest Campbell, Clerk in Holy Orders and Archdeacon of Carlisle, of Gerald Edward Maude, of Number 14, Cranley Place, London, Esquire, and of Kighley John Hough, of Carlisle, Esquire (in testimony whereof they have signed and sealed this Scheme), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Kirklington shall be transferred to the said George Graham Kirklington; Henry Herbert, Bishop of Carlisle; Herbert Ernest Campbell; Gerald Edward Maude; and Kighley John Hough, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said George Graham Kirklington; Henry Herbert, Bishop of Carlisle; Herbert Ernest Campbell; Gerald Edward Maude; and Kighley John Hough, their heirs and assigns for ever as Trustees upon the trusts declared by a certain Indenture already prepared and intended to be executed by the said George Graham Kirklington; Henry Herbert, Bishop of Carlisle; Herbert Ernest Campbell; Gerald Edward Maude; and Kighley John Hough

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Carlisle.

**WHEREAS** the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the

19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 2nd day of July, 1925, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the Parish of Saint George and partly out of the New Parish (sometime Consolidated Chapelry) of Saint Matthew, Moorfields, both in the County of Gloucester and in the Diocese of Bristol:

"Whereas we are satisfied that the said Parish of Saint George and the said New Parish of Saint Matthew, Moorfields, are Cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said Parish of Saint George and of the said New Parish of Saint Matthew, Moorfields, which are hereinafter mentioned and described should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas by an Order of the Charity Commissioners for England and Wales, dated the 25th day of July, 1924, it is provided (*inter alia*) that, subject to the provision by us, the said Ecclesiastical Commissioners, of an endowment of not less than £100 per annum for the proposed new District to be formed out of the said Parish of Saint George and the said New Parish of Saint Matthew, Moorfields, (1) the Vestry of the Parish of Saint Nicholas, in the City of Bristol, as the Trustees of the Charity known as the Church Lands Charity in the said Parish of Saint Nicholas, shall pay out of the income of such Charity a yearly sum of £100 as an endowment for the said proposed separate District, and (2) the Vestry of the Parish of Saint Leonard, in the said City of Bristol, as the Trustees of the Charity known as the Church Lands Charity in the said Parish of Saint Leonard, shall pay out of the income of the latter Charity a yearly sum of £100 as an endowment for the said proposed District:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £100 per annum to the Minister of the said proposed separate District, so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

"And whereas the said grant of the said yearly sum of £100 will, after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accord-
