#### THE ROADS ACT, 1920.

##### COUNTY BOROUGH OF SALFORD.

Whereas by sub-section (4) of Section 7 of the Roads Act, 1920, it is enacted that the Minister of Transport may, by Order on the application of any County Council (as defined in Section 17 of the Act), after holding a public inquiry, prohibit or restrict, subject to such exceptions or conditions as to occasional user or otherwise as may be specified in the Order, the driving of mechanically-propelled vehicles of any specified class on any specified highway within the area of the council in any case in
